Board Resolution

• At the November 26, 2018, Board meeting, Trustees approved:

that Bellmoore School be temporarily changed to a K-6 school until a permanent solution can be found to solve the accommodation pressures.

- The report states that the new school on the Summit Park site will be assisting with the accommodation pressures at Bellmoore. Grades 7-8 students from Bellmoore will be attending this new school until a permanent solution is provided for Binbrook.
- At the December 17, 2018, Board meeting, Trustees approved:

Be it resolved; that staff apply the boundary review policy to the temporary accommodation strategy at Bellmoore Elementary (and to include other potential impacted schools) and report back to trustees no later than March 2019.

Boundary Review Process

Once a boundary review has been initiated, staff will take the following steps:

Step #1 - Create the Boundary Review Advisory Panel

The mandate of the Boundary Review Advisory Panel is to **advise the Superintendent of Student Achievement of possible options** after reviewing the guiding principles, receiving community input and providing local expertise.

The Superintendent of Student Achievement, in conjunction with the Planning and Accommodation Division, will then **recommend an option(s)** for Board approval.



Boundary Review Process

Step #2 - Conduct a Community Consultation

Consisting of a public meeting(s) to allow the community an opportunity to provide input regarding the proposed recommendation(s).







Boundary Review Process

Step #3 - Review Data from the Community Consultation

Consisting of the review of community feedback prior to formulating the final recommendation(s) to be presented at a Standing Committee or Regular Board meeting.





Boundary Review Process

Step #4 - Seek Board Approval

Consisting of the presentation of the recommendation(s), as well as the results of the community consultation, to the Board for their approval.

Role of Advisory Panel

The Boundary Review Advisory Panel will meet a minimum of once and will review the following:

- a) Rationale for change
- b) Preferred option(s)
- c) Enrolment & facility utilization impacts
- d) Financial impacts
- e) Transportation impacts
- f) Community consultation
- g) Implementation considerations including phasing in of a boundary change, timelines, temporary and permanent status of the boundary change.






- Address enrolment pressures and facility limitations at Bellmoore
- Create a more balanced and predictable enrolment between Bellmoore and the New School on the Summit Park Site
- Implement a strategy which is clear and concise for students, parents, staff and community

First Turn Last Turn Protocol

- Silently and simultaneously, each advisory member reads public feedback summary from each option and highlights three or four items that have particular meaning.
- 2. First panel member **reads one of their highlighted items** but does not comment on it. They simply name it.
- 3. In round-robin fashion, each panel member **comments about the identified item with no cross-talk**.
- 4. The initial person who named the item shares thinking about the item, and therefore, gets the last turn.
- 5. Repeat the pattern around the table.

HWDSB Option #1 (NEW) – Increasing JK Cap, No New Students

- The following scenario depicts capping Bellmoore's JK enrolment at 100 students in 2019, 110 in 2020 and 120 students in 2021 and beyond.
- No new students would be enrolled at Bellmoore in grades SK-8.
- All projected JK students beyond the projected cap and new SK-8 students from housing development and housing sales attend New School on the Summit Park Site.
- This option would incorporate a sibling rule that would allow incoming JK students with older siblings at Bellmoore to attend Bellmoore. Currently this would account for approximately 50 of the JK spots allocated to Bellmoore.
- This option would require an application, random selection and waitlist process for JK entry at Bellmoore for students without older siblings attending Bellmoore.
- This would separate new Binbrook families with students in JK and older grades.
- This option would also require the Board to clearly define what a "new student" means. New to Board? New to neighbourhood?



Information to consider for these options:

- Enrolment projections are based on applying the JK enrolment 3 year average and grade to grade retention averages of Bellmoore to the north and south boundaries.
- If the averages or retention rates vary in the north or south areas this can impact the enrolment next year.
- Currently, there are 10 FDK classes, 38 grade 1-8 classes and 1 spec ed class at Bellmoore for a total of 49 homeroom classes. This cannot be exceeded next year, there is no additional space.

Information to consider for this option:

- Initially, option has a little impact on enrolment at Bellmoore
- Enrolment remains high at Bellmoore because the north portion of the boundary has two residential developments under construction that will yield students in 2019, 2020 & beyond

HWDSB Option #3 - Capping JK & No New Students

- The following scenario depicts capping the JK enrolment at 100 students per year and no new students would be enrolled at Bellmoore in grades SK-8.
- All projected JK students beyond 100 and new SK-8 students from housing development and housing sales attend New School on the Summit Park Site.
- This scenario would allow JK students with and without siblings to enter Bellmoore but would require new families with students in grades SK-8 to attend Summit Park site. This could potentially separate new Binbrook families with students in JK and older grades
- This option would require an application and random selection process for JK entry at Bellmoore
