Dear Parent(s)/ Guardian(s),

As we near the end of the Accommodation Review Committee's (ARC) work, I would like to thank everyone for their participation so far, but would like to express that there are still many ways that parents and community members can participate in this process. The ARC Committee is made up of parents and teachers and is currently working on finalizing its recommendations to the Board of Trustees. At the final working group meetings, the committee members will be reviewing all the information they have received through the public meetings and will be preparing their report to Trustees, which will outline their recommended options. These meetings are open to the public for viewing, and you are welcome to attend and observe.

There is still one more **public meeting**, where you will have the chance to participate in a table discussion and ask questions about the ARC's preliminary recommendations. This meeting is being **held Tuesday**, **February 4**<sup>th</sup>, at Hill Park Secondary School beginning at 6:00 p.m., with doors opening at 5:30 p.m. to review the options that the Committee is considering. Currently we are reviewing four (4) options and they are available for preview prior to the meeting on the HWDSB web site at <a href="http://www.hwdsb.on.ca/elementaryarc/central-mountain/meetings/">http://www.hwdsb.on.ca/elementaryarc/central-mountain/meetings/</a> under "Public Consultation Meeting #4" in Elementary Accommodation Reviews under "Central Mountain".
