

Hello

I live in Ancaster and would like to provide my concerns to the public elementary schools review. The use of the Ancaster High green space for a new build is not the solution and to use it as such would be wrong. These lands are used by all residents of Ancaster.

To build a mega school along side a high school will be a breeding ground for additional problems with students interaction, age and stage appropriateness. It will also contribute to the congestion on Meadowbrook which would then have to be addressed. This has now made the opening of Talyor St. a consideration. The reason Taylor was closed was due to the death of a child within the Spring Valley community who was hit by a school bus. We as a community do not want a re-occurrence of this event, feel our community lifestyle within the quiet narrow streets should not be compromised or put seniors and children at risk because the HWDSB finds itself in a situation that they themselves have created.

The Ancaster High green space has always been considered low hanging fruit. It is always the first thing to be eyeballed during discussions of elementary and high school reassessment. Trustees have said that the Ancaster High fields as an option for a new school was brought up by Ancaster community members but truthfully when i have spoken to trustees in the past they have made it clear that these lands and what they mean to the community at large is of no interest. For this reason, I am reaching out to you for help in protecting these lands because once gone, there is no going back and the community will suffer.

The green space is used by all residents of Ancaster. They contribute to the health and well being of adults, seniors and children during a time when living an active lifestyle is more important then every, difficult and costly. Not all of these voices are being considered equally in the current Assessment public meetings.

In our current economic climate, these lands offer the most affordable activity to families in a community which is growing exponentially. World wide, numbers show that soccer is the fastest growing sport because of its affordability. Ancaster has been using these fields for soccer since 1959. Active healthy children, mean active healthy adults with team and leadership building skills, lower obesity rate, less pressure on our healthcare system and better adjusted individuals in our communities. These lands provide outdoor soccer opportunities for over 2,000 children within our community alone and this number is growing. In addition, they enable people to leave their homes, spend time outside and get to know their neighbours, establish relationships, get involved.

These lands also play a big part of Ancaster economically. For the past, 13 years Ancaster Heritage Days Tournament has played a big part in the Ancaster Heritage Day celebration. It is Canada's largest outdoor soccer tournament with over 15,000 players, families, spectators, community members and sponsors attending from as far as the United States housed right on the green space which is being threatened. With the

tournament come thousands of dollars into Ancaster and Hamilton small business. Grass root entrepreneurs, small businesses, coffee shops, hotels, restaurants, merchants, as well as charities such as Ancaster Community Services have an opportunity for great exposure and financial benefit. Jobs are created, youth have the opportunity to volunteer and repeatedly become active within their community instilling life long lifestyle choices and developing into active community members. When we help local people, we are putting food on tables, helping families that live next door and building our community.

Heritage Day and the Heritage Day Tournament is an enormous draw for our community. Its a cultural event that enables us to carry on the tradition of what Ancaster is and its sense of community. It puts Ancaster on the map in a changing world. The loose these lands for a new school build would be detrimental to Ancaster. Maintaining green space in the core of Ancaster is critical. As the west of Ancaster gets further developed and even areas like Oak Gables having been sold off to developers, growth is coming at us from all sides faster then ever. With every lot of land at risk from being snatched up by hungry developers, if a new school is needed, it should be rebuilt on its existing site. Green space which is clearly used by the community consistently should not be threatened. It should be preserved for future generations.

CA Bray has been on the "No-Fix list" since 2012, at which time the school was already in a horrific state. The school board is responsible for the schools, it has received provincial funds for their upkeep and have chosen to do nothing. The School boards have neglected the upkeep of schools, closed them down, widened boundaries, sold off lands to developers (Maple Lane School), in today's environment everything is up for sale. Build the school on its property. Let the rest of ancaster be unaffected by your immediate need.

I humbly request your consideration of what this green space means to our community and our future and ask for your help to save it.
