3. Outdoor Projects:

-The first shed has been put up in the junior end; haven't yet figured out how best to organize storage. Have budgeted \$500 - \$600 for shelving system. Might be possible to purchase at Loews. Will need people to put this together. Should be getting 2 more sheds late this week/early next. Matt (Raglan's dad) to build? Lock has been ordered and has arrived. Kim S. to purchase mesh ball bags.

-Canadian Tire donated 24 basketballs and 72 soccer balls (thanks to Holly D.)

-Looking at purchasing picnic tables. Originally quoted \$2838.87 for three metal tables. Price is going up on June 9, so best to buy them now. Would like to purchase a 4th table so can seat a

whole class. Looking at approx. \$4000 for all 4 tables. Motion to buy four picnic tables put forward by Laura H. Motion approved.

-So far have spent a total of \$2453.05 on outdoor improvements (not including paint - \$75). Have \$6700 left over, \$5200 of which has been approved for the purchasing of picnic tables, shelving/hooks for shed, and a new basketball backboard for junior end. This leaves us with \$1500 unspent.

4. 2017-2018 HAS Budget*:

-This year we raised approx. \$12,000 from our fundraising efforts. Our projected income for the following year is \$12,500 from the Fortinos' Fundraiser (\$1000), Movie Nights (\$1000), Groove-a-thon (\$6000) and Fun Fair (\$4500). Below is a list of our expenses for the upcoming year:

-\$95.00 to be allotted for bank fees

-\$1500 to be allotted for September start-up funds

-\$500 to be allotted for spirit wear stock

-\$600 to be allotted for membership/conference fees

-\$250 to be allotted for stationary and stamps.

-\$250 to be allotted for food and drinks for meetings/events.

-\$300 to be allotted for Grade 6 graduation.

-HAS to spend up to an allotted \$3000 for class trips (this includes one trip or \$10/every child at Rousseau)

-\$500 to be allotted for Science Fair

-\$250 to be allotted for Parent Engagement Night

-\$500 to be allotted for "Free" events (Pancake Day, Hot Dog Day, etc.)

-\$300 to be allotted for Staff Appreciation

-\$1000 to be allotted for multiple-grade bussing (track & field, swim team, etc.)

-Total expenses: \$9,045.00
