## **Executive Summary**

The purpose of the *Ontarians with Disabilities Act* (ODA) is to improve opportunities for people with disabilities and to provide for their involvement in the identification, removal and prevention of barriers to their full participation in the life of the province. To this end, the ODA requires each school board to prepare an annual accessibility plan; to consult with people with disabilities in the preparation of this plan; and to make the plan public.

Bill 118, the *Accessibility for Ontarians with Disabilities Act, 2005*, was passed by unanimous vote by the Ontario Legislature on May 10, 2005. The purpose of the Act is to develop and implement and enforce accessibility standards to "achieve accessibility for Ontarians with disabilities with respect to goods, services, facilities, accommodation, employment, buildings, structures and premises". The Hamilton-Wentworth District School Board is proud of Ontario's advancement in accessibility. We look forward to the collaboration between the Ministry of Community and Social Services and the Ministry of Education for information, direction and funding for accessibility as the standards developed as a result of this Act are released for implementation.

This is the ninth annual plan (2011-12) prepared by the Hamilton-Wentworth District School Board. The plan describes: (1) the measures that Hamilton-Wentworth District School Board has taken in the 2010-11 school year and (2) the measures that Hamilton-Wentworth District School Board will take during the year 2011-2012 to identify, remove and prevent barriers for people with disabilities.

Hamilton-Wentworth District School Board is committed to the continual improvement of access to school board facilities, programs, and services for students, staff, parents/guardians, volunteers and members of the community with disabilities. This is accomplished through collaboration with people with disabilities in the development and review of the annual accessibility plan, and through the continual review of all school board policies and practices.



#### **Definitions**

#### **Disability**

The <u>Ontarians with Disabilities Act (2001)</u> adopts the broad definition for disability that is set out in the <u>Ontario Human Rights Code</u>. Disability is defined as:

- (a) any degree of physical disability, infirmity, malformation or disfigurement that is caused by bodily injury, birth defect or illness and, without limiting the generality of the foregoing, includes diabetes mellitus, epilepsy, a brain injury, any degree of paralysis, amputation, lack of physical co-ordination, blindness or visual impediment, deafness or hearing impediment, muteness or speech impediment, or physical reliance on a guide dog or other animal or on a wheelchair or other remedial appliance or device;
- (b) a condition of mental impairment or a developmental disability;
- (c) a learning disability, or a dysfunction in one or more of the processes involved in understanding or using symbols or spoken language;
- (d) a mental disorder; or
- (e) an injury or disability for which benefits were claimed or received under the insurance plan established under the Workplace Safety and Insurance Act, 1997.

#### **Barrier**

A barrier is anything that prevents a person with a disability from fully participating in all aspects of society because of his or her disability.

**Architectural** barriers may result from the design of the building, shape of rooms, size of doorways, or width of hallways, for example.

**Physical** barriers refer to objects added to the environment, such as doors, windows, elevators, furniture, bathroom hardware, etc.

**Information or communication** barriers make it difficult for people to receive or send information. For example, a person with a visual disability may not be able to read print materials, read signs, locate landmarks, or see a hazard. A person with an intellectual disability may not understand information that is not expressed in plain language.

**Attitudinal** barriers refer to persons who do not know how to communicate with people with disabilities, or persons who display discriminatory behaviours.

**Technology** barriers refer to devices such as computers, telephones, inadequate or inappropriate assistive technologies.

**Systemic** barriers can result from an organization's policies, practices and protocols if they restrict persons with disabilities.

## **Purpose**

The purpose of this plan is to describe the measures that Hamilton-Wentworth District School Board has taken, and will continue to take, to identify, remove and prevent barriers for people with disabilities who work in, use or attend school board facilities and services.

#### **Commitment to Accessibility Planning**

Hamilton-Wentworth District School Board is committed to:

- Establishing and maintaining an Accessibility Working Group
- Consulting with regard to the development and review of its Annual Accessibility Plan
- Ensuring that the Annual Accessibility Plan is in compliance with the legislation
- Improving access to facilities, policies, programs, practices and services for students, staff, parents/guardians, volunteers and members of the community.

#### Components of the Plan

#### 1. Processes

This section describes the processes by which Hamilton-Wentworth District School Board will identify, remove and prevent barriers for people with disabilities.

#### 2. Policies/Procedures

This section lists Hamilton-Wentworth District School Board policies and procedures that address accessibility in our schools and workplaces.

#### 3. Programs and Services

This section lists some of Hamilton-Wentworth District School Board's programs and services that most directly address the needs of students with disabilities.

#### 4. Integrated Accessibility Standard Regulations Work Plan

This section describes the plan for Hamilton-Wentworth District School Board to work towards meeting the requirements of the Integrated Accessibility Standard.

#### 5. Plan Availability

This section describes how Hamilton-Wentworth District School Board will make this accessibility plan available to the public.



#### 1. Processes

The Hamilton-Wentworth District School Board continues to identify, remove, and prevent barriers for people with disabilities through the following processes:

#### **Architectural**

The Board continues to move forward on its vision of School Revitalization by building new schools with accessibility features.

As a feature of the Boards' School Revitalization Program all newly constructed schools incorporate Barrier Free Design. In most cases minimal requirements identified within the Ontario Building Code (OBC) are exceeded to permit improved accessibility for both adult and child occupants.

Wherever possible, major renovation projects undertaken at school sites strive to incorporate OBC requirements, as well as meeting the provisions of the ODA and the AODA.

#### **Physical**

Hamilton-Wentworth District School Board continues to access the Ministry of Education Special Equipment Amount (SEA) funding, which assists with the costs of equipment essential to support students with special education needs. This equipment provides students with accommodations to attend school (such as adjustable desks, computer tables, positioning devices for sitting/standing/lying, personal care items, and lifts or harnesses for moving students) and/or access curriculum (such as computers or communication devices).

Each year the HWDSB allocates an amount from the annual School Renewal Grant (SRG), provided by the Ministry of Education, to address school accessibility issues. Identified projects may be part of an annual building renewal program (ie: washroom upgrades, auditorium upgrades), or to meet the emerging needs of a specific handicap (accessibility upgrades – ramps, visible fire alarms, acoustic treatments). This program also includes improvements to Board Administrative Facilities, as required. Many of the Boards' facilities were constructed when accessibility features were not a high consideration. Consequentially, there are limitations at some sites where accessibility features are not feasible, or practical, to meet all the provisions of the ODA.

#### **Information / Communication**

The Board's website continues to be monitored to ensure accessibility to staff, students, and the community, including accessibility to JAWS, a web-page reader.

Hamilton-Wentworth District School Board Special Education Report addresses access for students with disabilities through program modifications, accommodations and alternative expectations. Amendments to the Report are reviewed annually. The Report is available on the Board website. Special Education and Curriculum staff continue to provide support to schools for learning in diverse, inclusive environments through the principles and guidelines provided by universal design and differentiated instruction, as outlined in the Ministry of Education documents <u>Education for All (2005)</u> and <u>Caring and Safe Schools (2010)</u> and the draft document <u>Learning for All (2009)</u>.



#### **Attitudinal**

In 2011-12, schools will again be provided with websites and information about such dates as World Diabetes Day in November and the International Day of Persons with Disabilities in December, and encouraged to have their staff and students participate in activities associated with these events and others.

Through *Character Builds* (a character development initiative), the Hamilton-Wentworth District School Board endeavours to help every student strengthen their character, become caring and contributing citizens, and reach their full potential. A focus on character development includes student engagement and supporting youth empowerment, which includes building a student's capacity to learn and grow while contributing to a positive school climate and a strong community.

Student Leadership initiatives provide opportunities for students to develop their leadership potential and to assume responsibility for leadership initiatives at their local schools that can address issues such as bullying prevention and raising awareness of issues facing physically and learning disabled youth and adults.

HWDSB believes in and promotes inclusive education as defined by the Ministry of Education: "Education that is based on the principles of acceptance and inclusion of all students. Students see themselves reflected in their curriculum, their physical surroundings, and the broader environment, in which diversity is honoured and all individuals are respected." (Ontario Ministry of Education, 2009)

The Hamilton-Wentworth District School Board Equity Policy states and affirms Hamilton-Wentworth District School Board's commitment to the principles of equity through inclusive programs, curriculum, services, and operations, in accordance with the Canadian Charter of Rights and Freedoms, the Ontario Human Rights Code and the Education Act. Equity awareness opportunities for both students and staff are provided throughout the school year and on an annual basis the HWDSB staff are provided with numerous opportunities to become informed and active participants in implementing the HWDSB Equity Policy. The Leadership and Learning Department also provides ongoing staff professional development opportunities through the Equity Department, including Equity inservices and training, for staff taking leadership in the area of Equity at the school level. Equity is the lens through which decisions are made.

## **Technology**

Assistive technology plays an increasing role in the provision of differentiated instruction. Hamilton-Wentworth District School Board continues to access the Ministry of Education Special Equipment Amount (SEA) funding to provide students with accommodations to access the Ontario curriculum and/or a board-determined alternative program and/or course. This equipment includes such items as soundfield systems, FM systems, computer hardware, computer software that provides access to curriculum, Braillers, and other communication aids.

The Board continues to provide assistive technologies to staff through its accommodation of personnel policies and return to work procedures. Embedded within these processes are opportunities for dialogue around staff needs, suitable accommodations and required assistive technologies.

#### **Systemic**

As policies/procedures are developed and/or revised, they will be examined to reflect Hamilton-Wentworth District School Board directions with regard to accessibility.



## 2. Policies/Procedures

The following Hamilton-Wentworth District School Board policies, procedures, programs, and services address accessibility in our schools and workplaces:

#### Policy 1.01 - Equity Policy

**Policy Statement:** Hamilton-Wentworth District School Board is committed to the principles of equity through inclusive programs, curriculum, services, and operations, in accordance with the Canadian Charter of Rights and Freedoms, the Ontario Human Rights Code and the Education Act. Equity Policy Supporting Guidelines: Antiracism and Ethno-cultural Equity; Anti-classism and Socioeconomic Equity; Sexual Orientation; Gender Equity; Persons with Disabilities; Interim Religious Accommodation Guideline.

#### Policy 1.03 - Medical/Health Supports Policy

**Policy Statement:** The purpose of this policy is to demonstrate the Hamilton-Wentworth District School Board's commitment to ensuring the provision of plans, programs, and/or services that will enable students with health/medical needs to attend and participate in school; share the responsibility for providing such plans, programs, and/or services with families and community agencies/partners; and ensure that key principles of independence, dignity, integration and equality of opportunity are reflected and valued in our learning and working environment.

#### Policy 1.04 - Accessibility Standards for Customer Service Policy

**Policy Statement:** The purpose of this policy is to demonstrate the Hamilton-Wentworth District School Board's commitment to providing services to our students, parents/guardians, the public, and our staff that are free of barriers and biases; ensure that key principals of independence, dignity, integration and equality of opportunity are reflected and valued in our learning and working environment; and demonstrate our belief in the strength diversity brings to our communities.

## Policy 4.03 - Accessibility (Barrier-Free) "Pathways" Policy

**Policy Statement**: It is the policy of the Hamilton-Wentworth District School Board to educate all students whenever possible in the home school. The ideal would be to provide the student independent barrier free access to all aspects of the school's programs. The Board is to have an ongoing strategic plan for new construction and renovation projects that includes barrier-free accommodation.

#### Policy 8.05 - Accommodation of Personnel

**Policy Statement**: Hamilton-Wentworth District School Board recognizes and accepts its legal responsibilities under the Ontario Human Rights Code and Workplace Safety and Insurance Act to accommodate the individual needs of persons with a disability, as defined under the Ontario Human Rights Code, in order to assist them in performing the duties of their jobs.

#### Policy 9.03 - Special Class/Program Locations

**Policy Statement:** It is the policy of The Hamilton-Wentworth District School Board that the special learning needs of all students, wherever possible, be addressed within the home school. When determining the locations for all elementary and secondary school special classes, a number of approved criteria must be analyzed and considered as part of the decision-making process.



## 3. Programs and Services

#### **Leadership & Learning Department**

Hamilton-Wentworth District School Board Leadership & Learning Department is committed to providing appropriate educational opportunities for improved student learning for all students. Many professionals, including classroom teachers, special education teachers, educational assistants, school administrators, special education consultants, special assignment teachers, speech and language consultants, psychoeducational consultants and social workers, provide the support services to students with special needs. The Board endeavours to meet the needs of all special education students in the most enabling environment, in accordance with parental preference. The special learning needs of students, wherever possible, can and should be addressed within the home school. Hamilton-Wentworth District School Board provides a continuum of special education supports and services for exceptional learners which includes this regular class placement and support, as well as special class placement and support, and connections to the community.

#### **Alternative Education**

Equitable and inclusive education programs are founded on the belief that success for all students in both secondary and elementary schools begins with a feeling of acceptance and inclusion of all students, and that students learn best when they see themselves reflected their curriculum, their physical surroundings, and the broader environment in which diversity is honoured and all individuals are respected (Ontario Ministry of Education, 2009). Alternative education programs provide opportunities for some students to enhance their personal and academic capabilities in an alternative manner or environment through positive student and teacher relations, and effective academic and social/emotional programming.

#### **Student Engagement**

Programs designed based on student interest and engagement include multi-credit packages which address contextualized lessons in academic classes, industry standard certifications, pathway-based field trips, guest speakers, job shadowing, and co-operative education. Specialist High Skills Majors (SHSMs) assist students in customizing course to fit students' career interests. A SHSM is a Ministry-approved specialized program in which students focus their learning on a specific economic sector, while meeting graduation requirements. Students gain job skills with employers, at skills training centres and at schools, all while earning valuable industry certifications such as Standard First Aid or CPR. SHSMs can lead to employment, apprenticeship, college, or university.



### **Community and Continuing Education**

Community & Continuing Education at the Hamilton-Wentworth District School Board is specially designed to offer a variety of programs for learners of any age.

Programs include:

Summer School programs to help student to repeat, upgrade a mark, transfer courses, or take new

credit courses

Credit Programs programs to make it easier for students to get needed credits by offering different

avenues that fit individual lives and situations

ESL programs designed for adults who require assistance in developing communication

skills in English

International Languages (Elementary)

program offers students an opportunity to learn and/or maintain a language other

than French or English and to develop an appreciation and sensitivity to the

cultural diversity within Canada

Night School programs to enable students currently attending a day school or adults to complete

credit courses at night

Student Improvement programs to assist elementary and secondary school students struggling with the

Ontario curriculum to get the help they need through after school remediation

programs

### **Hamilton-Wentworth Student Transportation Services**

Hamilton-Wentworth Student Transportation Services (HWSTS) is committed to the accommodation of persons with disabilities in our student transportation operations. We've also demonstrated that same commitment when we designed our workplace by ensuring accessibility throughout our office location.

In compliance with the Accessibility for Ontarians with Disabilities Act 2005, HWSTS makes all efforts to provide integrated schools transportation available for all students eligible for service. Where integrated school transportation is not possible or is not the best option, HWSTS provides appropriate alternative accessible transportation for students with disabilities. We implement this approach tangibly by utilizing our electronic routing software to examine all available fleet resources and to explore a wide variety of routing solutions to seek out efficient and effective transportation solutions for students.

To ensure we can provide specialized transportation services when required by students, HWSTS maintains service agreements with a number of service providers that include accessible vehicles in their fleet. These service providers also maintain in-depth training programs for their drivers, and their dispatching staff are accustomed to the unique situations that sometimes arise in the provision special needs service.

HWSTS staff also regularly liaises and consults with school staff, parents, and the Special Education Departments at both of our Member Boards to ensure we understand the needs of our students with special needs, and that we are providing appropriate service.

HWSTS will make every effort to commence service the next school day for the student, provided that all the pertinent details are reviewed and confirmation from the bus operator that the service can begin the next school day. Typically, the student's specialized transportation needs can be addressed and implemented as early as two days after receiving notification of the student's transportation needs.
