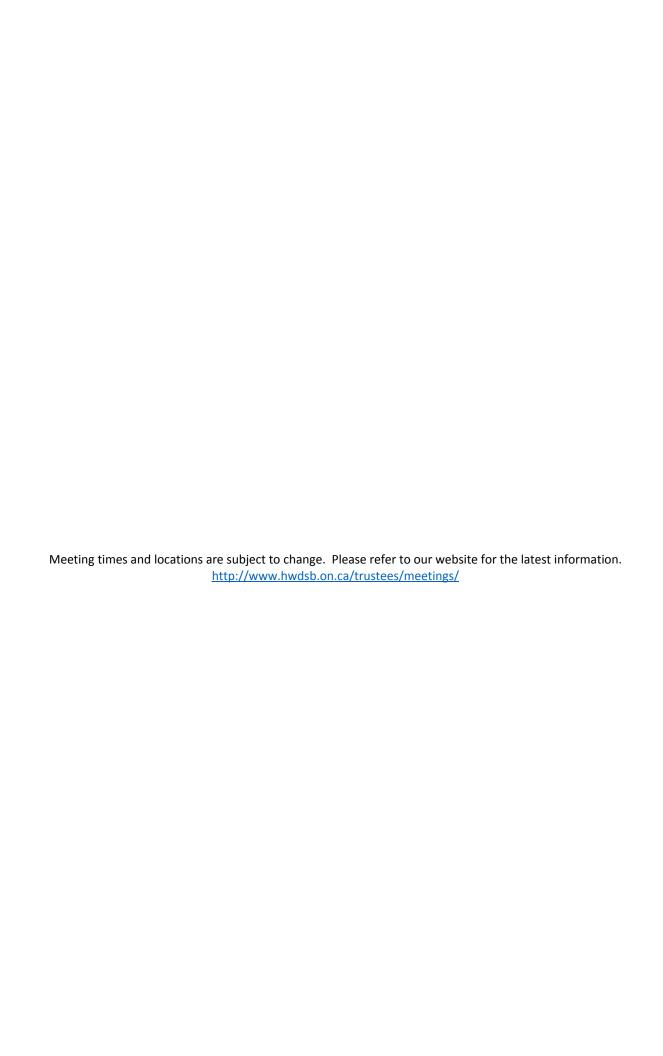

A. Student Trustees' Report

Student Trustee Wong shared that the OSTA-AECO President, Kayvon Mihan from the Ottawa-Carleton District School Board will be on TVO with Steve Paikin, speaking about student voice on April 25, 2017. The OSVA Award applications came in on April 17, 2017 and there are some HWDSB students who applied for the awards. Student Trustee Wong will be one of the people involved in choosing the winners. The OSTA/AECO are currently planning the upcoming AGM and Gala on May 25-28th. The Student Trustees thanked staff for all of their hard work and dedication for the Student Trustee elections that took place. She also thanked all of the candidates who ran for the position of Student Trustee.

Student Trustee Dockree shared that at the past Student Senate meeting the Board priorities were discussed. They received feedback on which priorities students felt were the most important and which priorities had the greatest impact on their daily lives. In both senates TLE was the priority that they felt had the greatest impact on a daily basis particularly for the grade 9 students and the introduction of the I-Pad yet it was ranked last in regard to its importance. When ranked from 1-6 TLE was always at the bottom with both student senates and it was the first to be removed. Students expressed that they feel that with all of the online learning they are losing a lot of the grass roots knowledge especially with the reduction of writing and paper in the classrooms. Special Education and facility updates were tied for the number one priority with both senates. At the upcoming student senate meetings on April 26, 2017 the discussion will include the PAR process and transitions.

B. Director's Report

The Director shared some highlights based on HWDSB's priorities.

Positive Culture and Well-Being – On April 6, 2017 the Director went to Sir Winston Churchill to celebrate the "Day of Difference." This was a conference hosted by both staff and students where they had keynote speakers. The "Day of Pink" was held on April 12, 2017 where the day of pink represents the vision of a world that is free of bullying.

Student Learning and Achievement – the Director once again visited some of the elementary schools, Glen Echo, Ridgemount, Glenwood and Janet Lee to see how the Board Annual Plan is being implemented especially around HWDSB's learning and achievement goals. .

School Renewal – The Director enjoys witnessing the school communities come together around the school renewal that is taking place when he is visiting the schools.

Effective Communication – The Assistant Deputy Minister, Martin Beckett, visited Dr. Davey and Nora Frances Henderson where he spoke to students and staff and asked "How are we implementing technology." He was so impressed with his visit that he has asked Nora Frances Henderson staff if they would be open to having Mitzie Hunter, the Minister of Education, come and visit to hear their journey over the past three years.

Partnerships - On April 19, 2017 at the Hamilton Community Foundation dinner the Director had the pleasure of seeing Dr. Jean Clinton present on the Adolescent Brain under Construction. It was a very important presentation held at the Hamilton Spectator Auditorium. She spoke of driving positive change and increasing post-secondary access. She spoke of how vital the middle school years are because of the changes that occur in the adolescent brain.

Trustee Hicks shared his concern over the low attendance of the 25 Year Celebration.

C. Chair's Report

Dear Minister Hunter:

Re: Request for Reduction of Class Size Requirements for Native Language Courses

At the January 24, 2017, Board meeting of the Thames Valley District School Board, Trustee Schuyler moved the following motion that was carried:

That the Chair of the Board, in collaboration with the First Nation Trustee write a letter to the Ontario Ministry of Education requesting that the class size required to offering Native Language be reduced from 12 to 5 students in Ontario schools. This would also be done in collaboration with the Federal Government who has the responsibility for funding First Nation education.

During the Truth and Reconciliation Commission, there were ninety-four calls to action that flowed from the abuses that occurred at residential schools in Canada. Through the atrocities that occurred in residential schools, our First Nations communities lost their language. Furthermore, their culture was denied by the government and churches that ran the schools.

As a result of these actions, it is incumbent upon the government to help ensure that our current and future First Nations students have the opportunity to learn their native languages and help open the doors to learn their culture. It is important that not only students on reserves are able to access language courses but also those First Nations students who are living in urban settings and attending a variety of our schools.

The Ministry currently has criteria for a class size of twelve (12) students for our school board to be able to offer a fully funded First Nations language class. This poses a major obstacle in many of our urban schools to run a class. Furthermore, when we do have the critical mass to run a class we are not able to recognize the diverse native languages that are found within our region. It contradicts the goals of the Truth and Reconciliation's Calls to Action to require an Ojibway First Nations child to learn the Oneida (Iroquois) language at their school. The Thames Valley District School Board urges the Provincial Government to work with the Federal Government and properly fund First Nations Language classes and reduce the class size to a minimum of five (5) students to ensure more students will have access to learn and celebrate their language and culture.

Thank you in advance for your attention to this matter. We look forward to working with you more as we move forward to improving our education system for all of our students.

Dear Prime Minister Trudeau:

Re: Request for Reduction of Class Size Requirements for Native Language Courses

At the January 24, 2017 Board meeting of the Thames Valley District School Board, the following motion was moved by Trustee Tisdale and seconded by Trustee Schuyler:

That a letter be sent to the Federal Government emphasizing their commitment and responsibility to fully fund First Nations, Inuit and Métis student's education.

Through the ninety-four calls to action in the Truth and Reconciliation Commission, our government has recognized the atrocities that occurred in residential schools that saw abuse of our students along with them being prevented from learning their language and culture.

As a result, there are concerns of First Nations communities losing their language and identity. Our school board would like to raise the concerns over the lack of resources that are currently being provided for our First Nations students on reserves. The fact that First Nations communities are provided less education funding per student than our provincially funded students continues the disgraceful legacy of previous governments that allowed residential schools to operate for so many generations.

Furthermore, we would like to ask that the Federal Government work with the Ontario Government to provide further funding for First Nations language classes for our urban students. Currently in our school board, the Ministry of Education requires a class to have twelve (12) pupils to be fully funded. This creates an obstacle when we are unable to create the critical mass needed in our urban schools with First Nations students. The

COMMITTEE REPORT

Presented to: Board Date of Meeting: May 15, 2017

From: Program Committee Date of Meeting: April 20, 2017

The committee held a meeting from 4:37 p.m. to 8:00 p.m. on April 20, 2017 at 20 Education Court, Hamilton, ON, in Meeting Room 340D with Trustee Dawn Danko presiding.

Members present were: Trustee Dawn Danko (Chair), Christine Bingham, Penny Deathe. Regrets: Alex Johnstone, Greg Van Geffen. Trustee Todd White was also in attendance.

ACTION ITEMS:

A. Secondary Program Strategy - Update

Staff presented the report providing answers to Trustee questions from the February 27th Program committee meeting and providing information on how HWDSB is looking to increase the number of SHSM programs being offered in order to reach the Ministry mandated goal of 25 percent of students being enrolled in a SHSM. Schools will be asked to submit applications using the guiding principles provided in the report. Trustees discussed the importance of communication to parents and students regarding SHSMs and what is, and could be, available. It was noted that it is important to ensure parents and students are aware that SHSMs are available for all pathways whether apprenticeship, college, community assisted living, university or workplace. Trustees also discussed the need to look at the definition of Tier 2 vs Tier 3 programming to try and avoid confusion as new SHSMs are created. It is important to ensure the system is strategic in terms of what is offered at schools to ensure it is aligned with the Secondary Program Strategy and student voice.

On the motion of Penny Deathe, the Program Committee **recommends:**

- A. That all schools be invited to submit applications annually in the sectors that they would like to offer SHSM programs in, based on student voice, course selection data and support of community partners.
- B. That multiple SHSM programs run within each school to reach the goal of raising SHSM program participation levels to at least 25 percent.

B. Referral motion to Committee: Toronto District School Board re: Changes to Curriculum Staff presented the report outlining the background of the Ministry mandate and policy around Equity, as well as where in the curriculum topics of racism are addressed. The report indicates that with the exception of Health and Physical Education at the secondary level, there are no explicitly stated overall or specific expectations related to anti-racism.

On the motion of Penny Deathe, the Program Committee recommends that the Board submit a letter to the Ministry of Education, in support of Toronto District School Board's letter, to request that there is explicitly stated specific expectations related to anti-racism added to the K-I2 curriculum.

MONITORING ITEMS:

C. Parent and Family Literacy Centre Update

Staff presented the report which provides an update on the transformation that will be occurring to the existing Ontario Early Years Centres (OEYCs) and Parenting and Family Literacy Centres (PFLCs) as funding and governance roles shift to the Municipality by January 2018. PFLCs will continue in operation until June 2018. These programs will be combined into a new system called Ontario Early Years Child and Family Centres (OEYCFCs). Staff are currently working and planning with multiple committees within the community, however at this time specific Ministry funding is not known. In addition, future locations of OEYCFCs are unknown. Staff hope to receive budget information by the end of June. Once funding and further information is received from the Ministry, staff will be able to provide Trustees with an update and follow up with more specific details.

D. Partnership Report

Staff presented the Partnership Report outlining the two goals that were identified this year.

Goal #1 was that all parents, guardians, caregivers and families are welcome, respected and valued as partners in student learning achievement and well-being.

HWDSB is currently <u>not</u> on target to have at least 75 percent of parents indicate that they have an awareness of what their children are learning by August 2017; currently we are at about 55-60 percent.

This was first year for the creation of the Principal Parent Engagement Lead (PPEL) group. The group is looking to have a Principal Toolkit (related to School Councils) available for September 2017. The PPEL group is also looking at improvements to the Hub and the login process to improve accessibility for parents and guardians. Staff are also exploring the use of digital tools to support "safe arrival checks."

Trustees requested a demonstration of the Hub portal which will take place at an upcoming Trustee Information Session.

Goal #2 is that all new and existing community partnerships will enhance opportunities for students.

HWDSB is on target with this goal. This year, there have been 157 new partnership requests made, 96 of which have been processed to completion. A database is being created with all partnerships with the hope that this will eventually be made available to principals who could search through partnerships we have to access different supports that could benefit their school community.

MONITORING ITEMS:

A. 2017-18 Budget Development

Staff provided an update on the enhancements to the Grants for Student Needs that was originally released on April 12. The Ministry has approved Extension Agreements for all of union groups which will allow for additional staff as well as a 1.5% salary benchmark increase for staff. Board staff is in the process of meeting with each union group in an effort to reach consensus on the priorities related to the additional staffing. In addition, there is funding for class size reductions in grades 4-8 (to be phased in over 5 years); an increase in Community Use of Schools funding to offset increased operating costs and Human Resources Transition Supplement to help boards manage the new extension agreements.

B. Secondary Facility Benchmark Strategy

Staff presented the projects that are planned for the 2017-18 school year related to the Secondary Facility Benchmark Strategy. 2017-18 is year 2 of 5 with \$55 million allocated over this period for this strategy.

MONITORING ITEMS:

A. Community Use of Schools Annual Update

In June 2016, the Board approved a number of motions related to Community Use of Schools including revised rental rates and a revised strategy for the use of the Community Use of Schools subsidy. One of the motions required that a report be brought back to Board in spring 2017, on the usage of the Board's Community Use of Schools and Priority School Grant Revenue, to determine if the overall usage of subsidy has transitioned to be within the total community use revenue received by the Board.

Staff presented a report that included information on the hours of use by the various categories of users and the allocation of subsidy dollars and the value of permits issued in 2016-17 by the different categories of users.

The Board's rental rates continue to allow for groups to access our spaces after hours with families and youth of Hamilton being the largest recipients of the subsidy dollars provided by the Ministry of Education. While the subsidy allocation still exceeds the grants provided through the Community Use of Schools and Priority School Initiatives by \$300,000, the deficit is much less than last year.

Trustees requested that this report be provided by staff on an annual basis.

B. 2017-18 Budget Development

Staff provided an update on the changes to the School Foundation Grant for 2017-18 and the impact on HWDSB. The overall impact of these funding changes to HWDSB will be an increase in funding of approximately \$400,000 which will be phased in over 4 years.

The preliminary 2017-18 budget revenue based on Grants for Student Needs (GSN) was presented and reviewed in comparison to the 2016-17 revised budget revenue.

Action X Monitoring

Recommended Action:

That the membership for the Faith Community Advisory Committee be approved.

Background:

On November 21, 2016, Trustees approved the following motion - RESOLUTION #16-196: That the Board establish a new Faith Community Advisory Committee.

Composition

Following the approval of the Trustee motion, staff began the process of data gathering to inform recruitment. Information was gathered from representatives of the former IFAC, through face to face and email, related to the work of the previous IFAC and considerations for the new Faith Community Advisory Committee. Staff also reviewed the structure of existing Trustee Advisory Committees (e.g. parent representatives, community representatives, student representatives etc.) for alignment.

Faith/Spiritual Traditions (parent/guardian/caregiver/faith leader) Representation
Staff considered faith representation within the Hamilton-Wentworth community. HWDSB does not have a system to track faith data. As a result, we utilized data from the 2011 National Household Survey. We looked at the faiths of both the overall population and the population of children under age 15. As a secular system we do not give primacy to any one faith so faiths were not weighted based upon population representation. Our goal is to maximize inclusivity and represent the faiths of students in our schools. The greater the diversity, the more informed our work will be.

This resulted in the identification of ten faiths for membership on the Faith Community Advisory Committee. This number allows for us to maximize the diversity of perspectives at the table. Staff believe it is important for us to endeavour to maximize voices heard.

Specifically, one parent/guardian/caregiver/community leader with a strong affiliation to HWDSB schools **and** a strong affiliation to one of the following faiths and/or spiritual traditions (10 people):

Community Membership (at large)

Membership also includes representation from the Interfaith Peace Group which allows us to further enhance our inclusionary approach as they are an organization representing multiple faiths with a focus on peace. The Hamilton Interfaith Peace Group is open to all faiths and currently includes members who are: Baha'i, Buddhist, Christian, Jewish, Muslim, and Unitarian.

Student Membership

Membership includes two student leaders who can bring the voice of students into the discussions. As an education system, we believe strongly in the voice of our students. We have many students who are strong self-advocates and who can bring the lens of faith and being a student to the table.

Recruitment

Opportunities to apply to become a member of the Faith Community Advisory Committee were accepted from March 6th to March 21st. Thirty-two applications were received. Communication of the opportunity included:

- Communication to all school administrators
- Information posted on HWDSB website and all schools
- Email to former IFAC members
- Email to faith organizations/groups listed with Inform Hamilton (approximately 300 contacts)
- Email to Parent Involvement Committee and Home and School Associations

A letter was sent to the Hamilton Interfaith Peace Group seeking a representative. Two student representatives were identified by Student Senate.

Membership Selection

A committee of staff met to review the applications and selection was made based upon the following criteria:

- Met basic criteria
 - o Parent/guardian/caregiver or community member with a school affiliation
 - o Identified faith/spiritual affiliation
 - o All sections are complete
 - "yes" answered to four competency areas identified by the Canadian Multifaith Federation (CMF)
- Ward Representation
- Strength of involvement in faith
- Strength of involvement in HWDSB schools
- Strength of explanations to the CMF competencies
 - Knowledgeable about religious accommodation and related rights and responsibilities
 - Knowledgeable about your own faith and/or spiritual tradition and respectful of multifaith identities and communities
 - Competent with interfaith dialogue and multifaith support
 - Knowledgeable about cultural diversity within faith communities

(Religious Accommodation in Ontario Schools, Canadian Multifaith Federation, 2016). The Community Member at Large position allows for representation that spans the changing demographic of our community in an inclusive and nonexclusionary way. The Community Member at Large organization, must be one open to all faiths with no primacy to any one faith.
