

- The Golf Tournament will be taking place on Friday, May 26, 2017 at Willow Valley Golf Club and to date this event has raised over \$10,000. This year's event will host dynamic and entertaining MC's.
- The first annual foundation report has been finalized and posted online.

D. Ontario Public School Boards' Association



The committee held a meeting from 12:00 p.m. to 2:20 p.m. on May 17, 2017 at 20 Education Court, Hamilton, Ontario in Room 340D with Trustee Wes Hicks presiding.

Members present were: Trustees Jeff Beattie (electronically), Christine Bingham, Dawn Danko, Wes Hicks and Greg Van Geffen. Trustee Todd White participated electronically.

ACTION ITEMS:

A. Elementary Facility Benchmark Matrix

Staff presented an updated Elementary Facility Benchmark Matrix for approval. The Matrix is attached as Appendix A.

MONITORING ITEMS:

B. Enrolment Summary - March 31, 2017

Staff presented the enrolment summary for March 31, 2017. Actual elementary enrolment is up 115 FTE from the revised projection. Actual secondary enrolment is up 123.25 from the revised projection. This results in a total increase of 238.25 from the revised enrolment projection. The report also provided actual ADE enrolment on a school by school basis from 2012-13 to 2016-17.

C. 2017-18 Budget Development

Staff presented an update on the 2017-18 Budget. The update included:

- An update on timelines
- An update from the March 29/17 budget draft where there was an outstanding deficit of \$657,000:
 - o Increased expenses related utilities, vice principals and other small adjustments of \$618,000
 - o Increased revenue related to updated Grant for Student Needs (GSN) of \$1,515,000
 - The reversal of the 4% increase to school budgets of \$250,000

The combination of these three adjustments results in a balanced budget position.

In addition, staff presented explanations for the difference between the 2016-17 Revised Estimates and the 2017-18 Budget revenues and expenses.

Staff also presented the 2017-18 Special Education budget.

ACTION ITEMS:

A. 21st Century Learning/Transforming Learning Everywhere Report 2016/17

Staff presented the TLE report, which outlines what has taken place to date and the implementation plan for the 2017/18 school year. Commencing in the 2017/18 school year, eBest's research plan will continue to focus on educator engagement and student engagement with an increased focus on student achievement, especially in our pilot schools. eBest will be investigating the use of Collaborative Inquiry along with technology to determine the impact on student achievement. Staff also presented the Financial Plan for TLE, which outlines actual and projected expenses and revenue sources from the 2014/15 school year up to 2020/21 (full implementation – 1:1 in all highschools and class kits for grades 4-8 in all schools). Moving forward, iPads will be leased as leasing has been found to be most cost-effective approach, providing the newest versions of technology on a regular basis with replacement plans. With respect to Ministry funding for TLE, staff are hoping to have more information by the next Program Committee meeting and will provide an update on that revenue source at that time. The Financial Plan will also be presented to Finance and Facilities as part of budget process.

On the motion of Alex Johnstone, the Program Committee recommends: That year 4 (2017-18) of the 5 Year Transforming Learning Everywhere (TLE) Implementation Plan be approved.







Capital Investment

The capital investment required for the final recommendation is shown in the table below. The recommendation proposes a new 564 pupil place JK-8 school on the CH Bray site and 495 pupil place JK-8 school on the Rousseau site. The recommendation proposes an addition of three FDK classrooms and addressing benchmark, accessibility and renewal needs at Ancaster Senior to create a JK-8 elementary school. The table below depicts the demolition, site prep and construction costs for the proposed new schools and addition. For a complete breakdown of accessibility, benchmark and renewal please see appendix-C from the Initial Repot: Feasibility Study.

The funding available to address these costs would be through SRG, SCI, SCC, capital priority grant.

The cost to bring all facilities up to current accessibility, benchmark and maintenance standards is an estimated to \$24.9 million according to the Initial Repot: Feasibility Study.

Timelines

All options follow the same basic timelines as the initial option. Timelines are dependent on project scope, funding, site plan approval, demolition/building permits and other regulatory approvals. Funding applications are completed on a bi-annual basis and the proposed projects may require multiple applications which would affect the proposed timelines.

Background:

On Monday May 30, 2016, Trustees approved the May 19, 2016, Finance and Facilities Committee report which advised staff to proceed with preparation for potential pupil accommodation reviews in 2016-17 for the following two areas: Ancaster and West Hamilton City (RESOLUTION #16-81).

On Monday November 14, 2016 Trustees approved the Ancaster – Pupil Accommodation Review – Initial Report (RESOLUTION #16-184) which initiated the accommodation review process for the following schools: Ancaster Senior, CH Bray, Fessenden, Queen's Rangers and Rousseau.

The Ancaster Advisory Committee comprised of parents, teachers and non-teaching staff began its work on November 29, 2016. The mandate of the advisory committee was to act in an advisory role that would provide comments and feedback on accommodation option(s) for the Board of Trustees' consideration. Over the course of an orientation meeting, six working group meetings, two public meetings and school tours the advisory committee formed a report containing key feedback for Trustee consideration and three accommodation options created by the advisory committee.

On Monday April 10, 2017 Trustees received the report which contained key feedback for Trustee consideration and three accommodation options created by the advisory committee. The report also described the public meetings and summarized the most common feedback from these meetings. As per the Pupil Accommodation Review Policy a public delegation meeting was scheduled for May 8, 2017. The delegations were advertised through letters home with students, HWDSB website, automated voice message and the newspaper. Members of the public were given until noon on May 8 to sign up for a delegation. 20 Ancaster delegates, 16 West Hamilton City delegates and 8 written correspondence were received by Trustees.
