Ancaster Senior, CH Bray, Fessenden, Queen's Rangers and Rousseau





- 1. If a school closes, what happens to money raised by fundraising? What if fundraising dollars purchased technology what happens?
- Any reserve funds would be proportionally transferred to schools receiving students.
- Purchased technology (i.e. IPads) would follow a similar procedure
- Excess classroom technology and equipment not purchased through fund raising dollars is redeployed at other schools if not required at receiving schools





- 2. If a school closes, do staff follow the students— is there a standard practice?
- Each of the Collective Agreements is different
- Different protocol will address each situation
- In some cases it may provide opportunities for existing staff to move with students where in others it will be dictated by the collective agreements provisions





3. What temporary accommodations are needed if Queen's Rangers is closed, a boundary review is completed but the new Beverly Central is not yet completed – what is the timeline?

Queen's Rangers student transition determining factors:

- Outcome of Ancaster accommodation review May 29, 2017
- Outcome of proposed boundary review June 2017
- Results of funding application(s) to Ministry of Education Fall 2017+
- Completion of New School on Beverly Community Centre Site –
 September 2018





- 4. If Queen's Rangers is kept open, can a boundary be adjusted to include population that would otherwise be directed to Beverly Central what is the impact on Bev. Central?
- If Queen's Rangers were to remain a JK-6: To be at 100% utilization Queen's Ranger requires approximately 100 additional students from the Beverly Central/Dr. Seaton Boundary.
- Removing 100 students from the New School on Beverly Community Centre Site boundary would result in a utilization of approximately 80%.
- Impact on business case submissions for Ancaster schools.





- 5. What traffic studies have been completed around CH Bray and Fessenden?
- No traffic studies have been completed at this point
- Studies may be completed at the Site Plan Approval phase where parking, loading layout, vehicular access and maneuvering are all addressed





- 6. What is the estimated bussing time for QR pupils to CH Bray is it within the Board policy of 60 minutes?
- Transportation for any accommodation solution will follow the Board Policy of a maximum 60 mins oneway ride.

- 1. What will happen to the SAGE program if Strathcona is closed?
- Under the Staff Recommendation, the program would become part of the new school population
- As the new school proposal is JK-8, the program would be housed there through to grade 8, alleviating the enrolment pressures at Ryerson
- Ryerson currently houses the 6-8's SAGE program for this community





- 2. What traffic studies have been completed for the Hess Street School and Sir John A Macdonald area what roadblocks will the LRT put in place for students walking to school?
- HWDSB has not conducted any traffic studies for Hess or SJAM
- Studies may be completed at the Site Plan Approval phase where parking, loading layout, vehicular access and maneuvering are all addressed
