Hamilton-Wentworth District School Board is in compliance with all Ministry elementary average class size requirements in 2017-18. The Class Size report filed with the Ministry indicates that 90.3% of HWDSB primary classes have 20 or fewer students; 100% of primary classes have 23 or fewer students, full day kindergarten average class size is 25.6 and average junior/intermediate (grade 4-8) class size is 24.74.

For 2017-18, the Ministry made a commitment to invest in reducing large class sizes in Full Day Kindergarten and Grades 4-8. The revised regulations continue to require an average FDK class size of 26 or fewer students, but now also require at least 90% of FDK classes to have 30 or fewer students. Up to 10% of FDK classes can reach 32 students if they meet one of the following exceptions: a) if purpose-built accommodation is not available; b) if a program will be negatively affected; c) where compliance will increase FDK/Grade I combined classes. For 2017/18, HWDSB had 1.8% or 5 classes with up to 32 students.

For Grade 4-8, the Ministry has committed funding to reduce class size to 22.85 over the next 5 years for boards which currently have class sizes of 24.5 or less. Any board with a regulated class size greater than 24.5 will be required to reduce class size to the extent that can be supported by the additional funding. For HWDSB, the revised regulated class size for 2017-18 for Grades 4-8 was 24.75 for which we are compliant at 24.74 as at the reorganization date.

### **Background:**

Enrolment plays a very key role in the operations of a school board. The Average Daily Enrolment (ADE) is the basis for the Grant for Student Needs (GSN) which is 99% of a school boards funding. The ADE is calculated by taking the average of the full-time equivalent (FTE) on October 31<sup>st</sup> and March 31<sup>st</sup>.

Each year, enrolment is projected to determine the budgeted revenue for the following year. On October 31st, Board staff calculates the actual FTE enrolment and compares it to the projections.

### Staff Observations:

Board staff is reviewing each school with Principals and Superintendents of Student Achievement (SOSAs) to determine the reasons for the changes in enrolment versus projections. As numbers are still coming in and being reviewed, a verbal update will be provided at the meeting.

The projected enrolment will be used in the Revised Estimates that are due to the Ministry and secondary staffing will be adjusted accordingly in second semester in necessary.

### **Background:**

For the 2017-18 Budget and prior years, Board staff has engaged in a public consultation on the budget priorities that guide the development of the annual budget for that year. The consultation usually took place during the month of February. The consultation allowed HWDSB to inform the public of its priorities, while soliciting feedback on what, if any priorities should change. For the 2016-17 Budget, HWDSB did not undertake a consultation on budget priorities as there was consultation going on at that time for the Board's Strategic Direction.

#### **Staff Observations:**

Board staff does value the feedback from the public and in the past has used this feedback to help inform decisions made regarding the budget.

If the Board would like to engage in a consultation on budget priorities for the 2018-19 Budget, Board staff would need to start preparing for the consultation. The timeline would be:

- November December determine the budget priorities
- Priorities approved for consultation in January
- Consultation performed in February
- Report back to Finance and Facilities Committee in March and final approval of budget priorities.

#### **Conclusion:**

In prior years, the Board has engaged in public consultation regarding budget priorities. Board staff is looking for direction as to whether the Board will continue to engage in consultation so that it can begin preparing for the consultation, if desired.
