- 1. What is the cost of remodelling SJAM vs. rebuilding on SJAM for an elementary school?
- Remodelling SJAM would require a feasibility study and would result in approximately 125,000 SqFt of excess space
- Estimated costs for a 600 pupil place school is:
 - •\$12.8 million for the school
 - Plus any additional site remediation costs

- 2. What footprint determines a single-storey vs. a multi-storey building? Show in chart format, including examples of what is currently in our inventory chart to include # of pupil placements, # of storeys in the building and square footage?
- Storey footprint is dependent upon:
 - City regulations building bylaw regulations (height, set-backs), required parking, etc.
 - The characteristics of identified site(s)
 - For example is there enough property to have a playfield if the building becomes a 3 story in place of a 2 story?

1. When will staff consider using HWDSB \$ to complete some of the capital projects on the list?

- Staff submit business cases to the Ministry for capital funding, either through Capital Priorities or School Consolidation Capital grants. If unsuccessful, staff will revise and resubmit the business case in the next round of funding, based on feedback from the Ministry. In the event that a project continues to be unsuccessful, staff will report back to Trustees through Finance & Facilities Committee, and provide a recommended strategy for direction.
- Trustees will continue approve the priority projects submitted under each grant after the Ministry announces opportunities.
