- Staff hiring is a controversial issue. Meetings with unions have taken place.
- Bill 103 (Ontario Teachers Act) was passed.
- Legal matter under Consortium was delayed until spring.
- Bill 107, Conservative bill regarding fair hiring failed.
- Governance Week was observed with school visits by trustees.
- OPSBA's Poverty Reduction Strategy submission
- Upcoming Ministry of Education meeting on Efficiencies and Modernization further details are coming.
