We've allocated funds for Food Cupboard, Home and School Discretionary Fund, Principal's Discretionary Fund, Grade 8 Grad, OFHSA (Ontario Federation of Home and School Associations) – Membership Fee & Insurance, Basketball Paint and Kinder Grad event = \$9115.00 Will still have about \$9000.00, if all funds come in.
