In the past we've tried to spread the funds around the school, into school beautification, musical instruments, Phys Ed equipment, things for the robotics club, etc.

### Elections and Fundraising and Insurance, Updates and Open Discussion:

This is Reasa's last year as our Chair. She encourages someone to step forward and co-chair so that someone can learn the ropes. The commitment involves overseeing the actions of the committee, chairing meetings and keeping the group united.

Andrea offers to type up a How-To binder to record how things are run yearly (i.e. fundraisers, etc).

Taking on the role of Vice President and all elections, can be table until later in the year if anyone wants to take on a role later on.

#### **Fundraisers:**

**Fuel for Kids:** New this year. We were approached to have Dave Connelly come to talk to our students about race car driving, safety, etc, do some donuts and hold a BBQ at Fortino's on Monday Sept  $23^{rd}$ , 4p - 7p. We need about 6 people on board to run this event.

**Monday Pizza Lunches:** We hold this annually. It is very popular – raises about \$16,000.00/year. The time commitment is about 2-hours/week to help out. Kristi handles the details behind the scenes.

**Thursday Box Lunches:** Done through the Lunch Box company. We offer different things weekly (Subway, Swiss Chalet – not continuing Pita Pit or Golden Pita. Could add Boston Pizza – though not offering pizza. They have pasta with garlic toast no can have salad with grilled chicken. Will try it for 3-months and review.) The time commitment to help with this is 45-minutes/week on Thursdays.

**Meet the Teacher BBQ:** Thursday October 3<sup>rd</sup> – Harvey's comes and prepares the food. We sell tickets, sour keys, etc. Families see their kids' class and meet the teachers.

**Buffalo Wild Wings Dinner Nights:** Easy one to set-up, flyers sent out to families. It's a nice community get-together. BWW gives us 15% of profit.

**Holiday Bazaar:** Held the second Friday of December. This year it will be held Dec 13<sup>th</sup>. We members buy items that historically get sold to kids at \$1 each. A lot of fun for everyone.

**End of Year BBQ:** We used to run a Spring Fling, but can no longer have Bouncy castles, etc, which affected sales/profits, etc. Instead we had a BBQ with the school Open House and it was easy to do. Had Harvey's in to cook the food. We try to have all-beef hamburgers and hot dogs as well as pizza for a Halal/vegetarian option.

**Vesey's Bulb and Flowers:** We held this for the first time last year. It went over well.

**Freezie Day:** Held when we have leftover Freezies from other events.

EQAO Ice Cream Party, Grade 8 Grad Dinner & Dance and the Food Cupboard are not fundraisers, but are also handled by Home and School.
