Came across FlipGive and FundScript. We could register for one or both. Every time people purchase gift cards, a small allocation goes to our group. Each retailer involved offers a different amount of donation.

Some retailers in our Esso, Kelsey's, Indigo, Marshall's, Amazon, Best Buy, Giant Tiger and more. We could request a payout at different amounts. The other service offers two payouts a year, otherwise there is a service fee attached for the transaction.
