- Chair: arranges/send notifications and chairs meetings, prepares meeting agendas, posts the
 agenda on the school website 48 hours before the meeting and circulates to School Council
 membership, ensures meeting minutes are recorded and maintained, communicates with the
 Principal on behalf of the Council.
- **Co-Chair**: Supports the duties of the Chair
- **Secretary**: Takes meeting minutes, provides drafts for Chair and Principal approval, shares minutes with broader council once approval is received.
- **Treasurer**: Oversees all financials of Council. Works with school office admin to maintain budget, submit receipts, etc
- **Member at Large:** Attend meetings, vote and give input as needed.
