## ATTESTATION FORM

Just a reminder that each morning a parent needs to complete the **STUDENT COVID SCREENING TEST** for each person in the household. You can find it on our website. This tool is to help you determine if you are well enough to attend school. If a student becomes ill during the day parents will be contact to pick them up. Student can only return back to school after the **RETURN TO SCHOOL ATTESTATION FORM** is filled out. You can find it on our website.

## HYDRATION STATION

Water fountains are closed. Students will obtain permission to fill up their bottle and follow floor markings to ensure physical distancing. Please insure you clearly label your child's water bottle. There is no sharing of bottles.

## PARENT PICK UP

Adults must wear face coverings while on school property. This includes the playground.

At the end of the day, **kindergarten** students who will be picked up will be dismissed at the back of the kindergarten play area.

For *Gr* **1**- **3**, students will be dismissed from their outside designated areas at the back playground. These areas will be marked for your convenience.

For *Gr* **4-8**, there will be no pickup on the school playground. These students are old enough to meet parents/guardians at prearranged locations near the school but away from congested areas near the school, e.g., a sidewalk, the pool, or park.

Upon dismissal, students must leave school property in a timely fashion. Only students who ride the bus will be permitted to exit the front doors at dismissal time. Even then, these exits will be staggered.

# LATES/ LUNCHES

With all transitions there is an adjustment period that we all go through. There have been many parents dropping students off late, and bringing water bottles, lunches and or wanting to see their child and coming into the school. Following Public Health protocols there are to be no outside visitors in the school. If your child is late walk them to the door and office staff will take care of them. Please try to refrain from bringing lunches to school and have your child bring a homemade lunch in the morning.
