Dear Honourable Liz Sandals, Minister of Education;

I am writing to request an Administrative Review of the accommodation review process undertaken by the Hamilton Wentworth District School Board for the following school(s): Hillcrest, Parkdale, Rosedale, Roxborough Park, Viscount Montgomery, W.H. Ballard and Woodward Avenue.

On June 16th, 2014, the Board of Trustees voted to close Woodward Avenue and Roxborough Park schools and to investigate putting offices into W.H. Ballard to fill the school to a higher utilization.

We are writing because we feel that our ARC members were greatly influenced by one of the representative Trustees from the area. He held a private meeting with the 13 community members and outlined a plan he thought the board would accept. From the point of that meeting onward many members on the committee kept to that option rather than participating with the other members in finding alternate options, or even hearing out other member options. These community members were told that there was funding for a new school if we asked for it, and many on the committee from that point forward felt that asking for a new school when we were being asked to close so many was acceptable and possible.

Also the other representative Trustee (for one school) presented the option that was ultimately accepted by the board of trustees. His option presented information that \$4-5 million was available for renovations/upgrades etc. for schools in our area. This information was never made available to the ARC members for consideration. His idea is to put that money into a non-accessible school and rather than have those students attend their 6-8 school (one of the largest and most underutilized) to put offices in that school and keep the non-accessible school open. This was never discussed with ARC members — in fact, we were not made aware of any attempt of the board of trustees or school board with regards to seeking out community partnerships to maintain the smaller community schools, or any of the schools for that matter.

We don't feel that the impact on our community was considered or weighted accordingly. Woodward Avenue school is the centre of our community, we do not have any churches, community centres or other meeting areas, the 6 other schools in our ARC process all have these facilities that create a community. Our catchment area is very large already as it encompasses an isolated part of Hamilton – the Beach Strip. The loss of Woodward Avenue School would be a detriment to our community, people will not move to the area and anyone seeking to sell their house will suffer a loss of property values.

Attached please find our petition and an invitation to a meeting and a follow up e-mail from Trustee Ray Mulholland with regards to a confidential meeting with 13 community (non-staff) members. Unfortunately I do not have the documents he handed out at the meeting with me presently.
