The 2022-2023 MELD Community Access Award

Established in 2019 by the McMaster English Language Development (MELD) Office. A tuition, course materials, and fees waiver to attend the MELD Diploma program, valued at approximately \$30,000, to be awarded to up to 10 individuals living in the City of Hamilton that demonstrate financial need and are looking to improve their English language skills to achieve their personal, academic, or career goals.

Application Eligibility Requirements -

- Currently hold at least a high school diploma or expect to complete their high school diploma by June 2022
- Have obtained a minimum IELTS score of 5.0 (or equivalent CLB 5 or CEFR B1)
- Permanently reside in the City of Hamilton
- Demonstrate financial need

Documentation Requirements

1) A 250-word Statement of Interest

How could the MELD program help you achieve your personal, academic and/or career goals?

2) Proof of High School Completion or Current High School Enrolment

Official transcript or letter from your high school

3) A Nominator's Letter of Recommendation from a school or community partner who is able to confirm your family circumstances and your fit for the MELD program

4) Proof of IELTS Score of 5.0 (or equivalent CLB 5 or CEFR B1)

5) Evidence of Financial Need:

a) A Description of your/your family's financial situation and details of any special circumstances that would be helpful in the evaluation of your application (maximum of 200 words)

b) Proof of 2020 Family Income for you/your parent(s)/your partner

Please provide one of the following: Notice of Assessment(s) issued from CRA, final pay stubs with year-to-date earnings, signed letter from employers, Social Assistance Benefit Statements, etc.

- *Proof of parental income is required if you have been less than 4 years out of high school and living with your parent(s)*
- *If you are married/living common-law, please also include proof of your partner's income*
- *If you have any dependent children, please include their names and ages*
