Millgrove Principal's Report - December 2020

Current student population is 140 in-school & 28 remote school

5 student teacher candidates – Mrs Di Toro, Mrs Price, Mrs May, Mrs Bailey and Mrs Nedelko

School day – Students in grades 1-5 are eating in their classroom 15-20 minutes before recess. Recess continues to be 40 minutes twice daily (this includes 20 minutes Daily Physical Activity which is mandated by the Ministry and which the kids need). Students must stay with their cohort group at all times. We will discuss at the staff meeting having a traditional nutrition break in the morning and 40 minutes in the afternoon in the new year.

School yard – Outdoor activities with snow – buckets have been purchased for building and seem to be providing some creative play for the students. Reminder to send spare masks, a water bottles and winter wear (extra socks and gloves!)

iPads were distributed in Ms Stevens class a couple of weeks ago. iPads have arrived for Mrs May's class but the tech has rescheduled his time to come in and image the last 2 weeks so we are still waiting to distribute to the kids. School photo day is set for February 1 – details to follow.
