Review of (Recommended) Options

- Question: Why did the staff recommended option change from Hillcrest to Parkdale since the first Advisory meeting?
 - Number of programs currently at Hillcrest
 - Natural transition from Parkdale to W.H. Ballard all students move (not just FI)
 - No perfect option

Feedback from Public Consultation Meeting

- Review of participation at public consultation meeting 58 attendees (signed)
- Raw feedback and option maps distributed to members in attendance
- Review of most common concerns:
 - 1) AM Cunningham Gr. 1-8 Single Track FI
 - 2) AM Cunningham Gr. 1-8 Dual Track FI
 - 3) Transition concerns
 - 4) Concern for WH Ballard as a site
 - 5) Siblings

A.M. Cunningham as a Dual Track Program Feasibility

- BF explains feasibility using the Option 1A boundary
- By 2020, school enrolment would increase to 150% utilization
 - Require 200+ extra pupil places
- Would require applying for capital
 - No guarantee of approval from Ministry
- One of the Guiding Principles that trustees will look at is balance between English and French. WH Ballard would not represent a sufficient balance between English and French progeamming.

Question: Do numbers reflect loss of students to new Bennetto FI program? Answer: Yes.

 - Provide another middle school option (i.e., Delta site) consider other sites for more green space

 - Make AM Cunningham 1-8 FI school
 - AM Cunningham FI and English would feed to same school (i.e., all students would transition to WH Ballard)
 - Hillcrest dual tract Gr. 1-8 to minimize transitions
