#### **Transition Planning:**

Whenever there is a significant change approved by the Board of Trustees, including school consolidation, closure or major program relocation, this directs the focus of the following school year on the planning and implementation of the Board's decision. Consequently, the formation of a separate advisory group (Transition Committee) is established to ensure a smooth transition for students and staff of the affected schools.

- Transition Committees are led by the Superintendents and typically have a series of meetings
  prior to the commencement of the planned transition, including representation from each of
  the school's parents, students and staff.
- Transition meetings are open to the public and minutes are available to the community on the Board's website.
- These committees are imperative in this transition process, as they provide the community with collaborative opportunities to advise and voice concerns.

# **Approved Board Motion**:

At the December 18, 2017 Board meeting, Trustees approved the following for the French Immersion programming for East Hamilton and Lower Stoney Creek:





- French Immersion Programs at Glen Echo (Grades 1-5) and Glen Brae (Grades 6-8) to be relocated to Parkdale (Grades 1-5) and W.H. Ballard (Grades 6-8) and A.M. Cunningham (Grades 1-5) and the new school on Eastdale (Grades 1-8).
- Approval for Grade 1 French Immersion to begin at Parkdale and Green Acres (French Immersion *Holding School* while Eastdale is being constructed) for September 2018.
- Staff to commence engagement of the Transition Planning process with the affected school communities.

### **Transition Plan Parameters:**

- Grade 1 French Immersion starting at Parkdale and GreenAcres (Eastdale) in September 2018.
- Grade 6 French Immersion starting at W.H. Ballard in September 2018.
- French Immersion relocated from Glen Echo and Glen Brae by September 2020.
- Differentiated transition plans for East Hamilton and Lower Stoney Creek.

## **Community Consultation for Feedback:**

Superintendents facilitated a participation exercise with the attendees, to review the transition options at their respective stations, thus providing an opportunity for community members to voice their preferences, questions and concerns to be considered and recorded. This feedback will be forwarded to the staff for guidance in the formulation of a Transition Plan and Transition Report for the Board of Trustees for their review and final decision.

Superintendents reviewed the (3) options on the slide presentation for a transitioning French Immersion plan from Glen Echo and Glen Brae over the next three years, and there were two guiding questions to lead the conversation:

- 1. Preferred Transition Plan.
- 2. Priority Considerations.
