#### Virtual Classroom Guidelines for Privacy and Security

The privacy of our staff and students is always a consideration in physical and virtual settings. As we engage in virtual learning and use various platforms such as the Hub and MS Teams, we have created a <u>Virtual Classroom Guidelines for Privacy and Security Fact Sheet</u>.

Students and their families are required to follow these guidelines when participating in learning that is being done in "live" real time with an educator as well as during times when the student can do the activity or access the material/resource on their own.

# **Public Access to School Buildings**

The Ministry of Education has informed school boards that they can work with their local public health service on procedures for safe access to personal items in schools. A plan for building access by families is being developed. We will provide more information as soon as plans are finalized.

### 2020-21 School-Year Calendar

Every year, Ontario school boards must submit school year calendars to the Ministry of Education. Our Board of Trustees has approved our <u>draft elementary</u> and <u>draft secondary</u> calendars, but we are waiting for Ministry approval, which is delayed due to the closure. We will notify you when the Ministry approves our school year calendars.
