What is PLAR?

Prior Learning Assessment and Recognition (PLAR) is:

A formal assessment and credit granting process whereby students may obtain credits for prior learning.



What is Prior Learning?

Prior Learning includes:

The knowledge and skills that students have already acquired

Knowledge and skills were acquired:

- In both informal and formal ways
- Outside secondary school



Prior Learning Assessment Recognition (PLAR) is not:

- An opportunity to learn course content, guided by a teacher
- An independent study

PLAR Process

Steps	Description
Getting Started	Connect with a guidance counsellor and access PLAR information on the HWDSB website
Application Package	Gather evidence of learning and application package preparation
PLAR Assessment	Complete assessment and evaluation
Recording and Reporting	Communicate final percentage grade to student, caregiver, and home

Who is eligible to submit a PLAR challenge?

 Current Hamilton-Wentworth District School Board students who are registered in a secondary school.

Is caregiver permission required?

Yes, if the student is under 18 years of age.



What courses are students able to challenge for credit?

Grade 10, 11 or 12 courses found in the Ontario curriculum and offered in the Hamilton-Wentworth District School Board.

How many courses are students able to challenge for credit?

Through the PLAR process, students may earn **no more than four** credits, including a **maximum of two** credits in any one subject area.

STEP 3: PLAR Assessment

Challenge Assessment Outline Administrative Focus

- Submit completed application package to your guidance counsellor
- Principal reviews the application package and forwards it to the Challenge Committee
- The Challenge Committee screens the application package
- The Challenge Committee assigns a subject specialist teacher to review the application package



STEP 3: PLAR Assessment

Challenge Assessment Outline Student Focus

The student may be invited to meet with the subject specialist teacher. This will be an opportunity for the student to demonstrate comprehensive learning of overall curriculum expectations.



How are my results shared with my school?

Your Guidance Counsellor will:

- Inform you of your PLAR results
- File the Final Report in your OSR
- Ensure your PLAR results are included on your Ontario Student Transcript



STEP 4: Recording & Reporting

The following will be recorded on the student's Ontario Student Transcript:

- A percentage grade for any successfully challenged Grade 10 course
- A percentage grade for both successfully and unsuccessfully challenged Grade 11 and 12 courses

How many courses are students able to challenge through Courses that are currently offered by the HWDSB. the PLAR process?

Students cannot be granted credits through the challenge process for any of the following:

- A course where a credit has already been granted
- A course previously attempted but not earned
- A course where curriculum expectations significantly overlap with those from a course where a credit was previously granted
- A course in any subject if a credit has already been granted in a higher grade in that same subject area



Students cannot be granted credits through the challenge process for any of the following:

- A course in English as a Second Language (ESL) or English Literacy
 Development (ELD), if the student has previously been granted one or
 more credits in English
- A locally developed course
- A cooperative education course
- A course in French as a Second Language if the student has one or more credits instructed in French
