Duties include, but are not limited to:

- Works independently to complete assigned work efficiently and economically ensuring compliance with the Occupational Health & Safety Act relevant regulations/building codes and Board policies/procedures. This includes, but is not limited to:
 - o Detailed troubleshooting and investigation of concerns
 - o Provision of estimates of time and materials for work projects assigned
 - Wearing personal protective equipment
 - Working from heights
 - Working in restricted areas (confined space/regulated substances)
- Perform preventative maintenance at assigned buildings
- Ensure that all HVAC equipment is operating to regulations and standards, analyze the efficiencies of existing HVAC systems to maximize energy savings
