To trustees of the HWDSB,

As a parent of children who attend Collegiate Avenue Public School, I've been increasingly frustrated with the process of how the school will be consolidated with Green Acres and R.L. Hyslop. I've outlined some of the main concerns that I have below. I know that many people in my community share the same concerns but have not had the chance to voice them due to how the HWDSB has dealt with this. Please consider the situation from the perspective of a parent as you read the following:

Lack of Information and Communication

In the last six months, we've really only received a sentence about Collegiate and what is being proposed with an addition. "The Ministry of Education has provided \$6 000 000 for a substantial 213 student addition that will include child care spaces". What I want to know is what exactly will be fixed and what will not be fixed. This information should have been made available well before December 18th. It was made clear on October 30th that the community has been left out of the loop. Apologies were made in addition to a promise for change. So we waited for a meeting or some information and have received nothing. This is unacceptable. I understand that the Collegiate situation is unprecedented. This is no excuse. There has been more than enough time to send a more detailed letter or hold a meeting. A meeting after the 18th is an after thought. People in the community were expecting that they would be consulted and given a chance to ask questions before a vote at the school board. If the answer is "we don't know what will be fixed, we don't have the plans yet"... this is even scarier. How can the board of trustees make a decision when the scope and scale of the project is unknown. The feasibility studies should already have been completed already. It doesn't make sense to jump into a project with so many unknowns.

Concerns about the Addition

Given the current political climate, an addition may or may not be the best way forward for Collegiate. I know that the Wynne government has put a hold on any school closures during the election season. They also might lose the election and the PCs have stated in their platform that they are against school closures. The question is, how substantial will this renovation be. I have no faith in the HWDSB in this case. They have allowed our school to fall to pieces and have found this to be totally acceptable for too many years. An old school does not have to be a school in disrepair. Schools of the same age where I work in Halton have been maintained and I would have no issue with my children attending these facilities. I want to know what items are going to be fixed no matter what. I want to know that if they suddenly find a new roof is needed that we will still be getting a renovated library. What items are 'maybe'? Will our children be receiving old, used furniture and materials if costs are too high in other areas. Hearing trustees make statements like "We shouldn't blow the budget on just one school" hasn't helped either. This is our school and our children will be spending most of their formative years there. Our neighbours, not too far away are receiving state of the art facilities. We've seen the slide shows. Since the HWDSB

has found the current state of Collegiate to be acceptable for years, I wonder what they will find to be acceptable moving forward.

HWDSB being run like a Dictatorship

During the three hour meeting on October 30th, it was clear that a majority of trustees supported a new build. Many of them stated this. However, the vote was split by the idea of re-applying to the government. Those same trustees who brought up the idea of reapplying to the Ministry, then argued against it when that motion was being debated. The idea of going to the government should have been debated first. These same trustees make up the bulk of the Finance and Facilities committee meeting. We have witnessed these trustees showing up half way through meetings and then voting. We have witnessed them debating motions that aren't even being discussed. We have witnessed these trustees coming and going as information about Collegiate is being presented. These are the strongest voices on the HWDSB board of trustees. They haven't even pretended to care about Collegiate and their tone has been arrogant and dismissive in my opinion. The board of trustees should be given the chance to vote on all three propositions again, with full information. It seems as though the whole situation has been manipulated and that doesn't sit well with many of us.

No Chance for Questions

Again, the addition might be the best way forward. However nobody has shown us anything compelling that points in that direction. We haven't been invited to participate in any discussions or meetings. It seems like dates have been chosen to exclude community voice and participation. The addition has not gone through an accommodation review process. It was not presented to the community. It was arbitrarily chosen by people who have likely not even set foot in our school. If our questions and concerns were listened to, we'd likely end up with a better school. We are the ones who see this building on a regular basis. We can look at a design and suggest things that might not work well. Some of our suggestions might not cost anything extra and might even save money in short or long term. We can also point out aspects of the building that we've noticed are in disrepair and might present a safety issue. Instead of inviting questions, we've had the opposite. It has been made clear that we are not part of this discussion. Again, given the current state of the school it is hard to trust that the school board will do this right.

Messing up the Application Process

Collegiate has been let down in the accommodation review and application process. For some reason we were put last on the list of priorities submitted to the Ministry of Education. At the meeting on October 30th or since, nobody could tell us why. Our school is the oldest after Mountain View. It is in the worst state by the province's FCI rating. Better schools are coming down while ours is being added on to. It simply doesn't make sense that our school would be the lowest priority. An explanation is owed to us on this one. Also, the enrolment projections done by the HWDSB are vastly different from what the province has come back with. The HWDSB has our enrolment being higher than schools like Eastdale, which is getting a full rebuild. So, whose numbers are correct? If the HWDSB is correct, and the province has it wrong that means that we'll likely be stuck with a slew of portables outside our old school with an addition. How could the numbers be so different? Furthermore, the HWDSB stated publicly that it would reapply if any of the schools were denied a rebuild. This came from the accommodation review process. That has not happened. Maybe there are good reasons for not applying, but nobody has bothered to explain them to the community. So the promise to reapply becomes a lie.

The HWDSB will make a Profit

Three valuable pieces of land are going to become available very soon. The marginal difference of \$3.5 million that it would take to rebuild Collegiate is well below what will be made in land sales. Perhaps this is the motive of those trustees who have worked so hard to prevent a 'fulsome debate' regarding what to do with Collegiate. Collegiate is out of their wards. Maybe this isn't the case, but it certainly seems like it. In addition to land sales, the HWDSB will be saving a great deal of money by having lower operational expenses when these schools are closed. Many of us feel that this isn't right and that in fairness, the money should be invested in building a school that is on a par with the new Eastdale and the new Memorial. Even with the additional \$3.5 million, there is a very good chance that the HWDSB will still make a healthy profit to spend elsewhere. Instead, all the students of Olde Town Stoney Creek will be housed in a second rate school while the money goes elsewhere. The land where R.L. Hyslop stands has been the site of a school for over 100 years, well before the HWDSB was created.

In summary, as parents many of us are worried about the facility our children will be sharing with more than 500 other students. To us, this isn't 'just one school'. It is our school. This is where our children will spend their first 10 years as students. We want it to be an excellent school that is a source of pride and inspiration for our children. Collegiate looks like it is straight out of a poor area in a third world country. Most of us work very hard and pay high taxes. It is bitter pill to swallow if our children continue to attend a rundown facility while our neighbours receive the best of the best. The HWDSB has messed this entire situation up for our community. I predict that trustees will vote in favour of an addition on Monday, December 18th. Possibly an apology will be made and a commitment to include the community moving forward. I hope that this commitment will be honoured and that it will not just be fake consultations where we get to speak and nothing we say is actually taken seriously.

Dear HWDSB Board of Trustees,

Based on the recommendation that is being put forward by the Finance and Facilities Committee on December 18th, it appears that the HWDSB is trying to push the decision for an addition to Collegiate Avenue School forward. How can the Finance and Facilities Committee put forward a recommendation for an addition to the school when the Olde Stoney Creek community has not been consulted and when a proper feasibility study hasn't been completed. In our experience, one would first gather the information needed and then make a decision, not the other way around.

Furthermore, we are deeply saddened by the fact that HWDSB has had since June 2017 to come up with a plan to properly re-engage the Olde Stoney Creek community and has failed to do so. This demonstrates a total disregard for the time and input of the Accommodation Review Advisory Committee, the concerns voiced by the parents during the Accommodation Review, and the concerns currently being voiced by parents and students.

When the HWDSB originally voted on June 6, 2016 to submit an application for funding to rebuild Collegiate, Memorial, and Eastdale schools, it did so based on a feasibility study for a rebuilt Collegiate Avenue School as well as a strong recommendation by HWDSB staff and the Accommodation Review Advisory Committee, and strong support from the entire community of Lower Stoney Creek. If there is a vote on December 18th to proceed with the addition to Collegiate Avenue School, the HWDSB will be doing so without a proper feasibility study for an addition and without the support of the Olde Stoney Creek community. If the goal is to provide the students of Olde Stoney Creek with a quality 21st century learning environment, how can the HWDSB make an informed decision without input from the community and without a proper feasibility study?

We request that the HWDSB Board of Trustees defer any vote regarding the future of Collegiate Avenue until the Olde Stoney Creek community has been properly consulted and a proper feasibility study on an addition for Collegiate Avenue School has been conducted and shared with the community. Furthermore, as part of the community engagement, we request the community be presented with information about a possible rebuild so that the community can properly compare a proposed addition against a rebuilt school on the Collegiate Avenue site. This will allow the Olde Stoney Creek community to effectively voice its concerns (i.e. traffic and safety issues, loss of valuable green space, quality learning environment, long-term financial impact, impact on local businesses).

Considering the long-term impact that the decision will have on the residents, businesses, and most importantly, the students of Olde Stoney Creek, we need to make sure that we have all the information needed to make the best decision possible. Otherwise, it will ultimately be the kids who will pay the price.

So you are here again deliberating on the future of Collegiate Avenue school. I would like to give you a fe w items to think about before you make your decision tonight.

First, community engagement was next to nil on this issue. Every parent that I spoke with was under the a ssumption that Collegiate is going to be completely rebuilt. These are R.L. Hyslop parents I'm directly ref erring to but I believe Green Acres parents are the same. Before the last meeting we could not get letters o ut to the parents for the life of us. The day if the meeting a handful were finally sent home, giving parents 30 odd minutes to arrange sitters and reschedule any other things they had going on. This meeting is also no different. Communication went home earlier about a done decision, with one tiny line at the bottom in dicating that the decision still needs to be voted on. So let me tell you now lack of community input at thi s time is not because of public acceptance but rather lack of information and basically thinking a rebuild i s going forward! In my opinion the board has failed miserably at informing the community on what it is w anting to do regarding this addition. The community meeting planned is AFTER the vote. From the comm unity's point of view this looks like the board is not taking any of their input into thought and just trudgin g ahead doing whatever they desire no matter who it affects. This latest push has left a sour taste in many parents mouths. We were told at the last meeting NOTHING will be done until after the holiday. Well sur prise! A quick vote was scheduled last minute during the busiest time of year. This looks very bad. It is ce rtainly seeming like a purposeful act by a few trustees to push this through without much backlash since n o one knows what is happening! The support a few gave in the last meeting indicating needing more infor mation and requesting the community be more informed has NOT happened. So the very reason the vote was deferred last time has not changed.

Next, I understand the trouble some of you were having justifying spending money on "just one school" but I think a very important point you are forgetting is that this one school is singlehandedly closing 2 other schools, so really 3 schools are under consideration. But more importantly there are/were 6 schools in this area, ALL neglected for the past couple decades while other schools got rebuilds, additions, etc. There are schools in other boards that are the same age in much much better condition because they've been maintained. Our schools were not. Bare minimums have been done for a VERY long time. So out of 6 schools you've spent incredibly little on over the past couple decades you now were asked to spend a little more but that was unacceptable. Think of the big picture having 6 schools off your books for the foreseeable fut ure. Obviously this would be the case of a rebuild as Collegiate would stay on the repair books with only an addition.

Lastly, again I understand the trouble accepting you would have to change your 8 year plan but you never considered Collegiate in this plan! If it was included from the get go, as it should have been, it would have changed the plan. This is very unfair to not include the school in your school betterment strategy and st ill deny reapplying for a rebuild which is why it was not considered in your plan in the first place. In summary this is a bad situation. The province made a poor decision which is not your fault but now yo u have the opportunity to make this better. Look at all the facts and see what really is fair, reapplying is sc ary but we owe it to the children to at least try to give them the best possible outcome!

INFORMATION:

A. Teacher Recruitment Update

Superintendent of Human Resources, Jamie Nunn, provided the committee with an update on the Board's Recruitment Strategy and promotional materials. The committee was informed of the challenges recruiting qualified French teachers. An overview of Regulation 274 was presented to inform the committee the steps all publicly funded school boards are required to follow when hiring for long-term occasional and permanent vacancies. Leticia Goddard, Human Resources Officer and Paul Baldwin, Manager of HR Staffing and Operations, joined the meeting to answer questions regarding the hiring process.

B. Enrolment and Staffing Update

Senior Manager of Business Services, Denise Dawson, provided the committee with a Secondary Enrolment Update. Projections in enrolment in the residential Stoney Creek mountain area were overstated as a result of slower than expected development. However, elementary enrolment came in 78.25 FTE higher than projected as a result of higher than expected growth from residential development in various locations across the Hamilton-Wentworth area coupled with the growth of the French Immersion Program at Sherwood.

C. Positive Culture and Well-Being Update

Superintendent of Leadership and Learning, Sharon Stephanian, joined by Director of Education, Manny Figueiredo, E-BEST Manager, Brandy Doan and Staff Development Officer, Kristin Roy, presented the Positive Culture and Well-Being Report to the committee. The report included the HWDSB annual plan, Student Positive Climate Data and Staff Positive Culture Voice Survey Data, Student Positive Climate and Staff Positive Culture Voice Survey Summaries and Suspension and Expulsion Data. Positive Culture and Well-Being is one of the five priorities of the HWDSB's Strategic Direction for 2016-2020.

ACTION ITEMS:

A. Collegiate Elementary School Capital Project

A business case was submitted to the Ministry for a 495 pupil place new build on the existing Collegiate property based on the motion related to the PAR that was approved by the Board. The Ministry gave approval for a \$6.0 million 213 pupil place addition on the existing Collegiate Elementary School. As this was not the option approved by the Board, the Finance and Facilities Committee asked staff to bring back information on 3 options (I – Proceed with the project as funded by the Ministry; 2 – Resubmit the Business Case for a new 495 pupil place school on Collegiate property; and 3 – Use \$7.8 million of the board's Proceeds of Disposition to Self-Fund the 495 Pupil Place New Build on the Collegiate Property). Staff presented the report which showed a possible configuration for the school site which included the addition.

On the motion of Todd White the Finance and Facilities Committee RECOMMENDS that the Board proceed with the project as funded by the Ministry: a 213 pupil place addition to the existing Collegiate Elementary School to support the consolidation of Green Acres Public School and R.L. Hyslop Public Schools.

The following **amendment** was moved by Jeff Beattie:

a) With a commitment to a phased design approach and financial monitoring updates to the Finance and Facilities Committee to ensure the project is feasible based on scope and budget.

CARRIED

The following **second amendment** was moved by Jeff Beattie:

b) With a commitment to a public engagement process on the proposed design with the first meeting to be held by December 22, 2017.

CARRIED

B. Elementary and Secondary French Immersion Boundary Review – Ancaster, Dundas & Flamborough

C. French Immersion Boundary Review - East Hamilton and Lower Stoney Creek (LSC)

Staff presented the report and committee members provided feedback on the boundary lines, proposed locations and transition timing.

On the motion of Todd White the Finance and Facilities Committee RECOMMENDS that the French Immersion programs at Glen echo (grades I-5) and Glen Brae (grade 6-8) be relocated to Parkdale (grades I-5) and W.H. Ballard (grades 6-8) and A.M. Cunningham (grade I-5) and the new school on Eastdale (grades I-8) be approved based on new boundaries.

The following amendment was moved by Todd White:

a) Further, grade I French Immersion is to begin at Parkdale and Green Acres (while Eastdale is being constructed) for September 2018 and that staff engage with affected school communities and return to trustees with a transition plan for current grade 2-7 students at Glen Brae and Glen Echo.


E. Elementary and Secondary Design Guidelines





INFORMATION ITEM:

Dr. Kathy Short, Director of School Mental Health ASSIST, provided a thoughtful and interesting presentation entitled "Mental Health and Well-Being in the Classroom". Dr. Short highlighted the overall plan for Ontario schools to promote mental health and wellness in schools, and noted that everyone has a role to play in supporting mental health and wellness at school.

Dr. Short pointed out that one in five students will experience a serious mental illness, but that up to 80% of children and youth who experience a mental health problem will not receive treatment. Despite the statistics, many mental health problems are treatable, particularly with early identification and intervention. Schools are an optimal setting in which to reduce stigma, promote positive mental health and build social-emotional learning skills, in addition to identifying students in need and building pathways to care.

In closing, Dr. Short reminded the audience what all students need at school:

- A warm welcome
- A smile
- A connection to a caring adult, every day
- A chance to learn
- A safe place to risk
- Someone who notices when something is wrong
- Someone who reaches out when they notice
- Someone who listens, and tries to find help for them
- Someone who believes in them, and instills hope

Dr. Short responded to many questions from the audience resulting from the presentation and reminded the audience to practice self-care.



Introduction

The Ontario Student Trustees' Association - l'Association des élèves conseillers et conseillères de l'Ontario (OSTA-AECO) is the offical representative of 2 million students in Ontario. As a nonprofit, nonpartisan organization, we work with the Ministry of Education and other major stakeholders in education, advocate on behalf of students at a provincial level, and provide comprehensive professional development opportunities for Student Trustees from Ontario's school boards.

The Ontario Student, Parent, and Educator Survey

One way we ensure that students' voices are heard is the Ontario Student, Parent, and Educator Survey (OSPES), which provides quantitative and qualitative results to information. This provincial survey was first conducted in 2010 and has been conducted four times since. We recognize that the education system exists to serve its students, therefore student consultation is imperative in the creation of policies and practices that shape our educational experience. We created this survey as a step towards maximizing student involvement in the education system. We hope these results will not only inform our stances as the official representative of students in Ontario, but also the positions of all stakeholders in education.

The following questions were posed to students, parents and educators across the province.

Each question provided the option of four responses: "Strongly Agree," "Agree," "Disagree," and "Strongly Disagree.

- 1. Financial literacy (the knowledge/skills relating to money) is taught sufficiently to students from Grades 7-12.
- 2. It is beneficial (more positive than negative) for students to wear school uniforms.
- 3. Technology is used effectively for learning at my school.
- 4. Students are sufficiently taught about the different levels of government and the roles they play.
- $5. \ \ There are adequate mental health resources and supports in my school.$
- 6. Student voice has a meaningful impact on decisions made in my school.
- 7. There are enough extra-curricular activities at school for students to get involved in what they desire.
- 8. Homework noticeably improves students' understanding of class material.
- 9. My school cares about students' health and well-being as well as their academic success.
- 10. Students in my school are all treated fairly, regardless of their race, sexualorientation, gender, or religion.
