There was discussion of concerns regarding the distribution of technology and mental health supports. Links were provided to mental health supports on the HWDSB website. OSTA - There is currently an Ontario wide equity survey being completed. OSTA is going through a Governance review as well.

B. Director's Report

- The Director spoke of the phases of response and how challenging this has been since the March crisis and how staff, students and the community responded when they first heard the news. There was a lot of confusion, ambiguity and anxiety and then they moved to some short term solutions.
- When looking at the Strategic Directions one of the big priorities that has been removed from our Board is school renewal. Trustees and Staff have worked hard to create a capital plan and now the physical learning environment is out of our control and this affects the learning environment for both staff and students.
- Another area that has been vastly been affected is equity and the HWDSB partnerships with the City, Public Health, nutrition partners, Hamilton Student Success Foundation, School Mental Health Ontario as well as many more have stepped forward. Thanks was given to the partners who have stepped in to support the mental health challenges as well as the need for food and nutrition. Thanks was given to staff who supported the distribution of food with our partners.
- The Director spoke of what is in our control which is to create a standard virtual learning environment and platform so that it is easier on our families and students. A report will be coming to the Program Committee in September around a standard virtual learning platform.
- Thanks were given to many staff who have stepped up and to trustees during this time of great uncertainty.

C. Chair's Report

- We are currently in week 6 of the school closures.
- The Chair shared how Trustees have stepped up to the challenges and are supporting their communities.
- The Chair spoke of the supports that have been available for our students and families.
- There have been a lot of good news stories shared e.g. sharing our PPE, provisioning 7000
 devices, equity in our technology, the donations that have been made from our partners as well
 as from other organizations.
- In times of need Hamilton and HWDSB pull together because the health and safety of the students and staff are foremost. HWDSB continues to work toward ensuring that the student's education needs are met in order to reach their goals.

INFORMATION:

A. Employee Attendance

Staff provided an update in regards to employee attendance reporting. Staff implemented the Employee Support and Attendance Management Procedure in support of the Attendance Management Policy 4.2 on September I, 2019. Staff absences have reduced by 0.74 of a day when we compare the number of sick leave absences from September 2018 – March 2019 to the same time period this school year (September 2019 – March 2020). We recognize the impact of the Ministerial Order on this data.

During the current Ministerial Order, staff continue to support staff who are absent from work and are in need of support as outlined within the Employee Support and Attendance Management Procedure. Staff continue to be on track to fully implement the Strategic Wellness and Absence Management Plan.
