9. Hamilton Foundation for Student Success

Trustee Fehrman shared the following update:

- Student Support Grants opened on October 1, 2025. These grants are intended to respond to the emergency needs of HWDSB students, and a student can receive a maximum of \$200.00 per school year.
- A 2025-2026 Enhancement Grant Program was launched, and schools were invited to apply for a grant up to a maximum of \$1000. Applications have closed and under review with decisions expected soon.
- HFSS Board of Directors is seeking one (1) Community at Large member and one (1) HWDSB staff representative to serve on its Board of Directors.

10. Ontario Public School Boards' Association (OPSBA)

Trustee Buck provided the following update:

- Local Government Week: Trustee Wong, White, Noble and Fehrman participated in school visits and civic engagement activities, helping students understand the roles of different levels of government.
- Advocacy Campaign: OPSBA launched a digital campaign to promote local democracy in education. Visit democracyisnotoutdated.ca to view the campaign and sign the petition.
- Central West Regional Meeting: Scheduled for Saturday, November 1, 2025, in Peel. All Trustees and Student Trustees are invited.

11. Student Trustees' and Shakowennakara:tats report

Shakowennakara:tats Hillen provided a verbal update:

- Attended the CC:Rose community gathering focused on creating spaces of belonging for Indigenous students and families.
- Participated in Sisters in Spirit Day to honour missing and murdered Indigenous women, girls, and two-spirit peoples.
- Represented HWDSB at the AMO Healthy Democracy Forum, advocating for youth voice in civic participation and leadership.

Student Trustees Bizanti and Watson provided a verbal update:

- Participated in the HWDSB AI Think Tank alongside staff and system leaders to explore responsible integration of artificial intelligence in education and its potential impact on classroom learning.
- Announced the first Student Senate meeting of the school year to be held on October 29, 2025, from 4:00 to 7:30 pm at the board office. All trustees and students are welcome to attend.
 - Shared plans to establish a Student Senate executive team with roles such as Social Justice and Equity Representative and Social Media Coordinator.
- Co-hosted the HWDSB Eco Summit, which brought together approximately 130 students from secondary schools to participate in workshops and hear from keynote speakers on environmental sustainability.

12. Director's Report

Sheryl Robinson Petrazzini <u>presented</u> the Director's Report that shines a light on the exceptional students, families and staff who make up HWDSB community:

- Local Government Week: Trustees visited schools across their region, sharing about the important role school board Trustees play in supporting schools and communities.
- Fall Edition of the 2025 Trustee Newsletter is now live and has been distributed to all HWDSB families, has been posted on our HWDSB website and featured across social media channels.
- This year, one of our overarching themes is going deeper with a focus on the 2025-2026 Board
 Improvement Plan. We officially launched an outstanding learning opportunity which involved a
 learning session day for principals, vice principals and system leaders from both Learning Services and
 Business Services.
- The expertise and dedication of staff and the voices of students, families and communities, HWDSB continues to be guided by a clear and compelling multi-year strategic plan that grounds our direction and aligns our collective efforts.

Chair Miller thanked the Trustees who participated in Local Government Week, Trustee Officer Miller for spearheading all the amazing sessions held with students, and to the Communications Community Engagement team for all the work behind the scenes in support of the recently released Trustees' Newsletter. ACTION ITEMS

A. Accessibility SCI Funding Update

On August 25, 2025, the Ministry of Education released Memorandum 2025: B03 – 2025-26 School Renewal Funding: Accessibility and Reinforced Autoclaved Aerated Concrete. HWDSB was allocated an additional \$5,811,583 for accessibility projects. Trustees previously approved the use of Proceeds of Disposition (POD) for three elevator projects. The elevator projects at AM Cunningham, Bennetto and Parkdale Elementary Schools are in various stages of completion, as communication through the quarterly Capital Project Update report and represents approximately \$3 million of POD being consumed to fund the projects to date.

On the motion of Maria Felix Miller, the Finance and Facilities Committee RECOMMENDS that the \$3 million Proceeds of Disposition allocation, approved through the 2024-25 Capital Budget for three (3) elevator projects (AM Cunningham, Bennetto and Parkdale Elementary Schools) be funded through Accessibility SCI funding and that the \$3 million of Proceeds of Disposition be returned.

MONITORING ITEMS

A. Recruitment and Staffing Update

As of September 30, 2025, the Board employs a total of 8,569 employees, including 6,206 permanent employees and 2,363 occasional or casual staff. Recruitment and staffing efforts have resulted in overall fill rates of 91%. The fill rates for Teachers are 96%, 74% for education workers, and 91% for CUPE and OCTU positions. Recruitment efforts for Secondary Occasional Teachers are ongoing with a focus on Technological Education, English, Math, Science, Teaching English Language Learners, ESL, Special Education and First Nations, Metis and Inuit Studies. Ongoing recruitment efforts continue for open hiring of Causal Caretakers and Educational Assistants. Between late summer and early fall, HWDSB received 661 applications across all staffing groups, leading to 258 interview invitations, 141 accepted interviews, and 131 successful candidates. In addition, 20 French occasional teachers were successfully hired and onboarded. The Recruitment Team continues to advance strategic hiring priorities through targeted outreach and expanded partnerships. New collaborations have been established with the Immigrant Women's Centre, YMCA, Goodwill, CNIB, Wesley Urban Ministries, and Employment Hamilton. Key initiatives include the upcoming launch of the "From Casual to Permanent" learning module for OCTU employees on the HUB. In-person application and interview workshops have resumed, with plans to expand these sessions to other casual employee groups. These efforts are further supported by the development of an "Equitable Recruitment" training module, which reinforces the Board's commitment to inclusive and innovative hiring practices.

B. Employee Attendance Monitoring Report (Sept 2024 – August 2025)

The HWDSB attendance rate is a review of personal illness, medical appointments, and dental appointments pursuant to central sick leave collective agreement provisions. From September 2024 to August 2025, permanent Board employees utilized an average of 14.09 personal illness days per 1.0 FTE. In comparison, the average was 16.85 days during the 2023-2024 school year. This is a decrease of 2.76 days per 1.0 FTE. The Employee Support and Wellness (ESW) Department continues to support staff with early intervention, return-to-work planning and accommodations and continues to monitor attendance rates while working closely with our Employee and Family Assistance Provider (EFAP), Homewood Health, in promoting available resources and services to support HWDSB staff through a variety of avenues.

C. 2024-2025 Workplace Violence Summary

Health and Safety (H&S) provide an annual summary of workplace violence reporting statistics. The data provided reflects reports received from staff where they believe the threshold of workplace violence as defined in the Occupational Health and Safety Act has been met. For the 2025/26 school year, multi-disciplinary teams continue to support school staff in their efforts with students. The Educational Assistant (EA) Onboarding has been designed to provide essential learning for EAs to prepare them to support a diverse population of students and Behaviour Management Systems (BMS) Training was expanded during the 2024-2025 school year. A review of Board procedures continues into the 2025-2026 school year, which includes consultation with union partners on our processes relating to responding to student need.

A. Board Improvement Plan 2025-2026

Director Robinson Petrazzini <u>presented</u> the <u>Board Improvement Plan for 2025-2026</u>, which is part of HWDSB's continuous efforts to enhance student outcomes and organizational effectiveness. The Director highlighted to the Committee that this is the third iteration of the Board Improvement Plan (BIP) since 2023 and reflects feedback from Trustees, Executive Council, Learning Services, System Principals, Managers and Hamilton Wentworth Principals Council.

Key Enhancements in the 2025-2026 Plan include:

- Greater emphasis on student voice and real-time classroom data, moving beyond reliance on EQAO (which is considered lagging data)
- New monitoring structure where goals are tracked at three levels student, classroom and school
- Data literacy support for Principals and Vice Principals
- An appendix was added to the BIP to guide staff on where to find data sources for each measure

The goals for 2025-2026 remain the same:

- Improve literacy achievement for every student
- Improve numeracy achievement for every student
- Improve preparedness for the future of every student
- Improve well-being for every student
- Increase engagement for every student

Trustees receive updates on the progress of the goals through reports to the Program Committee in March (literacy, numeracy, future preparedness), May (engagement, well-being), and a cumulative report in October 2027.

The Committee highlighted the following feedback:

- Appreciation for clarity, coherence, and alignment with strategic directions
- Recognition of equity focus and responsiveness to previous feedback provided
- Suggestions to improve website organization and centralize related documents (e.g., MYSP, BIP, Student Achievement Plan)
