Case Management


-Ongoing partnership with Public Health

Continuity of Learning

•Continuity of learning when a class or part of a class is temporarily selfisolating as a result of COVID-19

•When students and their educators are connected, student well-being and learning is supported.

•Educators are connected to their students at home while also being present for in-person students, using a number of strategies such as MS Teams and The HUB, HWDSB email, student/parent phone communication, and the sharing of learning packages.

Of those school board employees and trustees who have submitted an attestation, 92% of individuals have attested to being fully vaccinated.

- Regular rapid antigen testing requirements are in place for staff who are not fully vaccinated against COVID-19.
- Individuals who do not intend to be vaccinated, without a documented medical reason, will be required to participate in an educational session about the benefits of COVID-19 vaccination.
- Human Resource Services continues to share and distribute rapid antigen testing kits to appropriate staff and outline the testing requirements.
- Staff are required to test twice a week and upload their results. Human Resources will follow up with staff who are not compliant.



Immunization Disclosure Policy

Volunteers

- In person volunteers for activities that couldn't happen otherwise at guidance of Public Health
- Process managed by principal or vice principal for in person school volunteers
- Immunization Attestation kept in secure file by principal
- Volunteer Drivers for athletic events: meet outside, wear medical mask, passengers wear masks and sit in rear seats

Third-Party Service Providers, Partners, Contractors, Students on Placement etc.

- In person for essential services only at guidance of Public Health
- Process managed centrally by Superintendent or Senior Manager working with agencies and organizations
- Immunization Attestation kept in secure file

Elementary Fall Transition

• October 4th is the first day in new classes



- 1115 students participated in the Remote Parent Survey from September 3rd –10th
- 770 students will move to remote learning from in-person learning
- 345 students will move to in-person from Remote Learning
- The remote learning enrollment is 2160 students, 6% of the HWDSB enrollment.



Specialized Services

Nurses in Schools

- As a result of the province-wide nursing shortage, the Home and Community Care Support Services Hamilton Niagara Haldimand Brant (HCCSS HNHB) has been unable to find nurses to provide in-school nursing support for *some* students.
- From communication with the HCCSS HNHB there is no proposed date when health services might become available.



Specialized Services

Nurses in Schools

- Some students are able to attend school because the parent/guardian is available to administer/carry out the medical requirements
- Some students are not yet able to attend school because the parent/guardian is not available to administer/carry out the medical requirements. These students are being offered the opportunity to engage in remote learning.
- A few parents have decided to keep their children home until nursing support is available. These students will also be offered the opportunity to engage in remote learning.

Ventilation

- The <u>Standardized Ventilation Measures Report</u> is available on the Board's website
 - Each school's ventilation profile is available
- Construction continues for unfinished CVRIS projects
 - To be complete by the deadline
 - HEPA filters are still on site at all schools where construction is still happening

- The Board is not currently allowing community use of schools for the general public
- The Proof of Vaccination Guidance for Businesses and Organizations under the *Reopening Ontario Act* refers to "Indoor areas of facilities used for sports and recreational fitness activities"
- Board staff is determining how this would affect the Board if it were start allowing Community Use of Schools

Director Update: New Board Improvement and Equity Plan (BIEP) – May 22, 2022

The BIEP is a demographic data-driven tool designed to capture the experiences and outcomes of Indigenous students, Black and other racialized groups of students, students with disabilities and/or special education needs (non-gifted), 2SLGBTQ+ students, and students from low-income households. School boards will provide baseline data and set aspirational targets for each performance indicator laid out in the BIEP, including relevant disaggregated demographic data.

Achievement



All students, including those communities of students who - historically and currently - are underserved, will ill be given the tools to succeed academically and in life.



Mental Health, Well-Being and Engagement

All students will be supported to improve mental health, well-being and engagement, which requires boards to foster a sense of belonging and a positive school environment and provide students with the appropriate, timely and quality school-based mental health supports, using a tiered approach to intervention.

Pathways and Transitions

All students will have the skills, knowledge and confidence they need to succeed in the future, as they transition from elementary to secondary school and to their postsecondary pathway: apprenticeship, college, community living, university or the workplace.



Learning Recovery and Renewal

The ministry will identify a theme in the BIEP to respond to emerging priorities. The theme of the emergent priority is learning recovery and renewal in the context of COVID-19.



Human Rights and Equity



All students will have an equal opportunity to succeed, thrive, and reach their full potential. This requires boards to address systemic discrimination and eliminate disparities in educational experiences for students who are underserved by the education system, revealed by the collection and analysis of demographic data.
