While they did raise this to their admin, the admin did not do anything to help and the students who were saying these racist remarks left without any consequences.

That being said, the board should unquestionably address these issues and the discrimination and racism against Palestinian students. There should be appropriate consequences for students and staff who have committed these acts against students. To the Trustees of the HWDSB:

I hope that this email finds you well. The advent season, and the 51st day of the military conflict in Israel-Palestine is continuing.

My son could not sleep last night. Our guests, a Gazan family of 3 school-aged children, came to visit us. We learned that their 6 year old & 16 year old cousins have been trapped under the rubble of their home, crushed in air strikes over a week ago. They did not die immediately, they were starved, injured, and unable to move below the multi-story home that was hit by bombing. Their grandfather continues to use his hands to move concrete rubble to find the remains of his grandchildren.

My friends older daughters, themselves recent newcomers to Hamilton from Gaza, have been told to not wear kuffiyehs in school. The eldest was called to the Principal's office and interrogated as to whether she was planning any actions or walk-outs. She was threatened that she would be in "big trouble" if she did.

They are suffering from not only the losses of their family in the current conflict, they are made to feel erased, and invisible.

It is with this lived experience that I write to advocate for the inclusion of the motion to discuss *Anti-Palestinian Racism at the next meeting of the HWDSB. *APR is a concept that is perhaps unfamiliar to the Board, and requires serious reckoning if actual deep conversations on equity and student voice are to be protected. Understanding this is a volatile time does not erase our responsibility to protect the HWDSB and its schools as democratic spaces for dialogue, for students' free expression, and for a deep understanding of what hate is, and what it is not. I say these things as someone with a Master's of Education in Theory and Policy Studies from OISE/UT, specializing in Anti-Racism and Equity education, and an undergraduate degree and graduate degrees in Peace Studies (McMaster) and Peace and Conflict Studies (Eastern Mennonite University).

It is imperative that the discourse of "safety" not be used to restrict difficult but honest conversations about perspective-taking, about human rights. I note that the HWDSB has also been lobbied by groups who wish to silence and call out solidarity with Palestine. This is an important step- evaluating the merits of our dialogue, the limits of our knowledge, and listening to those most affected. A cornerstone of anti-racism is attending to voices most marginalized; the Board has done this well in the establishment of your own equity policy. Time

to add and consider the crucial importance of Anti-Palestinian racism, which cannot be done without historical and contextual nuance. It is also acknowledging the bias towards white privilege and towards Western Imperialism that supports war & has been complicit in casting brown and Muslim voices as "uncivilized" and "dangerous"--tendencies which have been historically present in the HWDSB's own Chambers. Anti-racism's ultimate goal is not to create only "safer" spaces, but to transform existing structures towards justice and liberation. As organizations such as Amnesty International and the United Nations' own Secretary General have stated, this is a genocide. You may wish to contextualise your engagement with students in policy with these non-governmental groups' voices, as well- lest we undermine
