1. Call to Order

Todd White, Chair of the Board, called the meeting to order at 6:06 p.m.

2. Approval of the Agenda:

3. Delegations: Naming of the New North Secondary

A. Tesla Delegation: Dr. Ishwar Puri, Dean of Engineering McMaster University, Mr. David Santi, Dean, School of Engineering Technology and Mr. Vic Djurdjevic, President Nikola Tesla Educational Corporation. Mr. David Santi spoke of the book of Henry Ford and the great ideas that he inspired. He spoke of manufacturing in the future and the importance of having technical students who are inspired to be creative. Dr. Puri shared that Canada is in last place when it comes to inventions and how in the early 1900's Canada was the leader in technology inspiration. Mr. Djurdjevic shared the importance of inspiring our students and not just by naming a school but by providing inspiration like Nikola Tesla has illustrated in the past and continues to do.

B. Shannen Koostachin Delegation: Amy Somers-Smith

Amy Somers-Smith shared a video about Shannen Koostachin. Shannon was a 13 year old Indigenous girl who fought for a proper school in Attawapiskat but who died in a car accident before she could see it happen. Shannen was an inspiration to people across Canada. Amy Somers-Smith shared that 20% of the students who will be attending the New North Secondary School will come from an indigenous background and a good portion of the remaining students will come from underprivileged families. She felt that Shannen Koostachin would continue to be an inspiration to the students if the school was named after her.

C. Bernie Custis Delegation: John William Jr.

John William Jr. shared some of his background and stated that he played for the Hamilton Tiger Cats and now works with Indigenous youth. He shared how he was inspired by Bernie Custis and how he broke the stereotypes and set the standards being the first black man to play professional football. John William Jr. explained how Bernie Custis changed perceptions and impacted many young people both during his athletic career and in his three decades as an educator. He stated that Bernie Custis represents an idea of what you can do with opportunity.

C. Hamilton Foundation for Student Success

Trustee Danko shared that the Foundation is now officially named the Hamilton Foundation for Student Success. She shared that the reason for changing the name was in order for people to understand that the Foundation is not part of the school board and is not publicly funded. They will be launching a new brand in the near future. Over the summer the Foundation has been working on revitalizing the strategic directions. The Hearts Open Gala will be held on Thursday, November 29, 2018 at Michelangelo's Banquet Centre.

D. Ontario Public School Boards' Association (OPSBA)

Trustee Johnstone shared the following updates:

- On August 24, 2018 Education Funding Update the Trustee Honorarium increases have been suspended. A freeze was put on all funding increases. It was also noted that Trustees will be losing the 1/3 tax exemption that they currently receive on their honorarium.
- On August 28, 2018 School Boards received notice that they are to create a math improvement strategy by November 30, 2018 to be submitted to the Ministry.
- On August 29, 2018 the Ontario Human Rights Commission under the Ontario Human Rights code staff received a report on how to best meet the Ontario Human Rights for students with disabilities.
- Municipal elections are taking place October 22, 2018 there are resources available on the OPSBA web site.
- The Education Reform on the Health and Physical Education Curriculum will be taking place this fall.
