### Background:

Each year, during the Organizational Board Meeting, the Trustees elect to be part of a number of committees outside of the mandated and trustee special committees.

Mandates committees in which some or all Trustees participate as members of include the following:

- Standing Committee
- Suspensions Appeals & Expulsion Hearings
- Parent Involvement Committee (PIC)
- Supervised Alternative Learning Committee (SAL)
- Special Education Advisory Committee (SEAC)
- Student Trustee Mentor

Historically, a Trustee has been asked to be a member of the *Health & Safety Committee* and it has been listed as a mandated committee. The Health & Safety Committee is a staff/operational committee required by legislation that our organization have. There is no obligation of this committee to have their terms of reference approved by the Board, nor does this committee report directly to the Board of Trustees. Trustees will continue to be informed of any concerns or issues that this committee raises through the Human Resources Committee, which Trustees are part of.

Staff suggest that the Health & Safety Committee be removed from the mandated committee listing as they no longer require a Trustee to be part of this committee.
