## **Trustee Professional Development Sessions 2025-2026**

#### **Recommendation:**

That the Trustee Professional Development Sessions 2025-2026 be recommended for approval.

### **Background:**

The Board of Trustees engaged in learning sessions throughout the 2024-25 school year on topics such as Human Rights Resolution Process, Indigenous Education, Engaging with Media, Motions, Finance and Audit and Mental Health in Schools. Trustees also learned about the supports and resources provided by the Program, Equity and Innovation department as well as the Specialized Services, Inclusion and Equity department.

The Board of Trustees Self-Assessment completed and presented to the Governance Committee in January and April of this year, identified topics for future Trustee learning sessions.

#### Status:

Staff propose a one-day learning retreat and approximately eight 50-minute Information Sessions for next year. All Trustees are encouraged to attend each session in person to fully engage in the learning with their colleagues. In extenuating circumstances, virtual participation will be available for a Trustee who requires an accommodation that prevents them from attending in person.

Trustee/Executive Council Retreat\* (early fall)

- "Leading with Courage, Compassion, and Collective Strength"
  - A day designed to build confidence in your leadership roles, strengthen working relationships, and explore ways to support personal and professional well-being while navigating the dynamic landscape of public education.

\*The above is a working concept being explored by staff, in consultation with the Chair and Vice-Chair. The retreat will be facilitated by a third-party who has experience working with Trustees and understands school-board governance.

Eight Information Sessions (50 minutes, scheduled throughout the year)

- "Money Matters: Your Role in Financial Oversight"
  - Finance Fiduciary Responsibilities (including audit, ministry funding, local budget process, etc.)
- "Shaping Direction: How Policies Reflect Your Leadership"

  - "More than Buildings: The Infrastructure of Learning" Facilities Services
  - "Connecting Classrooms: Technology in Education" Information Technology Services
  - o "People First: HR's Role in Educational Excellence" Human Resources
  - "Walking Together: Unlearning and Relearning in Indigenous Educational Wellness and Reconciliation" - Indigenous Education Department
  - o "Learning for Life: A look at Continuing Education" Continuing Education
- Open Session (2-3): To be determined to share information in a timely manner

In addition to the above, at the April Governance Committee meeting, there was a request to explore the possibility of hosting a meet and greet opportunity with City Councillors and Trustees. Staff will work with the Chair and Vice-Chair to further explore this opportunity and work towards scheduling this before the end of 2025.

### **Financial Implications:**

There are no financial implications for the topics currently identified as Information Sessions, as they will be facilitated by board staff.

However, when an external facilitator is required, the cost must fall within and be covered by the funding allocation provided by the Ministry of Education through School Board Administration Fund (SBAF).
