# **Proposed Policy Changes**

#### Purpose:

• HWDSB recognizes values, supports and expects the involvement of school volunteers to enhance all aspects of school life for the benefit of students.

#### Guiding Principles:

 Recognizing that volunteers from a diversity of lived experiences can enrich the school community and student experience.

#### Intended Outcomes

• Encourage and welcome parents, guardians and caregivers to participate in volunteer activities in our schools to support programs and services and help students succeed.



## **Action Required**

- Maintain a Volunteer Procedure that is accessible to the HWDSB community and communicated annually to community. The procedure will establish and maintain:
  - A clear process for the recruitment and selection of volunteers,
  - <u>Necessary training and/or orientation for our volunteers</u>, including our Human Rights and Equity policy, relevant information from the Freedom of Information Act, other Board policies, procedures and provincial legislation,
  - An outline about/information on <a href="https://www.new.num.nity.">how volunteers will be celebrated</a> and recognized for their contributions to the HWDSB community.

workspaces.



### **Key Updates in HWDSB's Code of Conduct**

#### 1. Enhanced Focus on Equity and Inclusion

- > Current: Emphasizes respect and dignity.
- > Updated: Integrates anti-racism, anti-oppression, and Indigenous reconciliation principles.

#### 2. Integration of Restorative Practices

- > Current Code: Non-violent conflict resolution.
- > Updated Code: Focuses on repairing harm and restoring relationships.

#### 3. Clear Guidelines on Digital Conduct

- Current Code: Lacks specific guidelines.
- Updated Code: Defines expectations for respectful digital interactions.

#### 4. Emphasis on Student Voice and Identity

- > Current Code: Encourages participation.
- > Updated Code: Centers identity and lived experiences in learning.

#### 5. Updated Provisions on Substance Use

- Current Code: General prohibitions.
- Updated Code: Includes vaping and cannabis, reflecting legislative changes.
