#### **Recommended Action:**

That the Election Procedure be approved for the purpose of filling the Trustee Vacancy for Wards I & 2.

#### **Election Procedure**

The following election procedure is designed to require that the successful candidate receives a majority (6) of the votes cast (except in the case of a tie).

Following the interviews conducted by the Board of Trustees with selected candidates:

- a. Voting be conducted by secret ballot. Due to meetings being electronic, votes will be submitted electronically to the identified scrutineer. All electronic records will be destroyed by the scrutineer at the end of each voting round.
- b. The Chair will announce the results of the vote, (who came first, who came second, etc. and if there was a tie) and there will be no disclosure of the number of votes cast for any candidate.
- c. That the following procedure for resolving tie votes be approved:
  - If no one receives a majority of the votes and a candidate receives no votes, the candidate who received no votes will be dropped from the next ballot.
  - If no one receives a majority of votes cast and there is a tie for last place (the candidate in last place would normally be dropped from the ballot), a draw will be conducted among the candidates who are tied and the candidate losing the draw will be dropped from the next ballot.
  - If there is a tie vote on the final ballot, the vote will be conducted once more before drawing lots (the Education Act requires the drawing of lots, Section 227).

- I have been a teacher...
  - for about sixteen years in publicly funded schools, and also
  - for about sixteen years in privately funded schools.

In the Hamilton and Grand-Erie areas I have taught high school classes for 14 years;

Before that, I taught in Alberta, Manitoba, and the Netherlands.

In the summer of 2007, my wife and I moved to Guangdong in China,

where we taught eight years, seven of these in a Manitoba accredited school.

After that we lived and worked for three years in my home town in The Netherlands so that we could give support to my aging parents, there.

Since the Fall of 2018, we live again in our house in West Hamilton (ward 1), purchased in 2001. As of January, 2020, I have been available as registered on-call teacher with the Six Nations schools. I have been serving there at all levels from K-grade 8. (Recently, I have limited my availability for this to two days per week.) When COVID brought the first lockdown, I worked on a mathematics support website at einsteinhelps.ca.

In fact, I have always tried to make myself available to serve my community. Some other examples of volunteering include:

- as registrar for the Dutch 4-Dy Evening Walk in the Royal Botanical Gardens
- as first president of the Hamilton Missions thrift store
- as Math department head at two high schools
- as health & safety officer with the OSSTF teachers' federation at Grand-Erie schools
- as organizer and coach in various school clubs (like Big Brothers, Arduino)
- offering free language help to recent immigrants and refugees

#### with my wife:

- providing support and accommodation to an international student and several refugees
- as SISO volunteers for refugees from Liberia and Myanmar
- started a fund to help U.N. registered refugees to come to Hamilton, Canada

I hope to get an opportunity to serve this year as trustee for the Hamilton-Wentworth District School Board.

I desire to see that our public schools provide a safe and effective learning place for children/young people of any gender, skin color, ethnic background, and religious persuasion, Etc. All children matter! I have no intention to be a trustee for the long-term and will not run in the Fall election of this year..

#### Letter of Interest

Let this serve as a letter of interest in serving the remainder of the term of service for the Trustee vacancy in Wards One and Two.

To help in your evaluation I have responded to the individual criteria you have listed.

Passion for Kindergarten to Grade 12 public education.

I attended Central Public, Ryerson Senior Public and Westdale Secondary Schools. My two children attended Earl Kitchener, Ryerson Senior Public and Westdale SS. All of these schools are within Wards One and Two. There is a history of service to the Hamilton public school board within my family which I value and this is one reason for me to put my name forward for consideration. My great great grandfather Peter Gage taught at Bartonville Public School. My grandfather George Gage and my father Cameron Gage both served on the Hamilton Board. My great great aunt Hazel Gage Roberts was the founding president of the Women's Teachers Federation and my sisterin-law Beth Grosso currently teaches at Central Public. All these individuals were educated in, and believed in, the public education system. I share this belief. My interest is to try to ensure that every child receiving an education within the HWDSB receives the best education available anywhere.

# Interest and insights into Wards 1 & 2 community.

I have always been interested in the welfare of the community as it is where I have lived since I was a child, my children were raised here and I served as trustee in Ward One.

Commitment to Truth and Reconciliation, as well as Equity, Diversity and Inclusion.

I am concerned that there may never be a true reconciliation but certainly I am committed to exposing the truth and seeking reconciliation. As to Equity, Diversity and Inclusion I am a person with a Scottish, Irish, English and German background who is married to an Italian. I have worked over 40 years in the water and wastewater industry which includes individuals from every nationality and colour and I have learned from experience that there is no justification for discrimination based on sex, sexual orientation, nationality, religion or colour. I do hope that the Board in their review of qualifications does not, by their own criteria for evaluation, discriminate against anyone.

Diverse lived experience to represent the changing, diverse lived experiences of Hamiltonians.

I am not an immigrant nor a visible minority nor do I have a native background. I have never been homeless or been in want of food or housing but that does not mean I cannot be sensitive to the needs of those who have. Having been educated in public schools I have been exposed to others who have a diverse lived experience. That is perhaps the most important feature of public education and why I believe so strongly in public education.

Married for 38 years, my wife and I have raised two children who have been successfully launched after receiving a public education. My daughter Alessandra took a Bachelor of Arts and Science at McMaster and a MSc at Oxford University graduating with distinction. She now works in Rome for the Food and Agriculture Organization of the UN, specializing in helping third world countries achieve food and water sustainability. My son Robert completed a degree in Engineering and a Masters in Naval Architecture at UBC. He now works as a naval architect in Vancouver. I completed a degree in science at the U of T and I have been working in the water and wastewater treatment industry since 1979. I have owned and operated my own company, Aqua Technical Sales Inc., for the last 25 years.

I do have experience serving on four different Boards including serving as the Treasurer and President of Houselink Community Homes an organization in Toronto that supplies housing for ex psychiatric patients in a non-medical model. Half of the Board was composed of members of the community who were homeless and required these services. That experience led to a strong belief in the importance of making decisions by seeking consensus wherever possible.

Previous board or public sector governance experience is an asset.

I served as a Trustee for Ward One alongside Judith Bishop in the last term of the Hamilton Board of Education. As only one person could serve for the ward in the following terms on the HWDSB I declined to run as I felt Judith Bishop was by far the best qualified to continue to serve. When Judith decided not to seek another term I ran. There were four men and one woman who ran. I came second ahead of the other men but behind Christine. Since my term as student trustee serving on the board from 2018 to 2020, I have continued to be heavily involved in the education system and committed to student voice through the Ontario Student Trustees' Association. Through the organization, I've gained invaluable experience supporting student leadership through my previous role as CEO from 2020-2021 and my current position on the Board of Directors acting as legal, regulatory, and financial support for the corporation.

In the last few years, we have seen unprecedented changes and challenges surrounding our school system, impacting students, families, staff, and our greater Hamilton community. Recognizing the adversity and need to adapt that the HWDSB and our school communities have faced, the posting for HWDSB Wards 1 & 2 Trustee Vacancy serves as an excellent opportunity to bring another dedicated voice to the table. I was born and raised in Ward 1 and have been living in Ward 2 for the past six years.

I attended West dale Secondary Highschool which was the first high school that had a LGBTQ and straight alley alliance club (and one of the first out gay principles!) My lived experience as a non-binary person, in addition to my lived experience with mental illness, allows me to view many issues from a perspective that is outlined as a need in the posting. The resources I had been connected to through the HWDSB, dedicated staff, and community services has brought me to where I am today, and I would be honoured to have the opportunity to generate such an impact for students and those in our school communities today. Addressing barriers to accessible and equitably distributed education is something I hold dear as a priority personally and would extend as a priority as Trustee in this vacancy.

Having grown up as a HWDSB student in a low-income household, I have an acute understanding of how this can impact students and potentially hinder student achievement. My unique life circumstances will bring astute experience towards this position for the next eight months. As I believe any public official should, I pride myself in community engagement, involvement, and action. I have also been working and volunteering in the community for ten years now. Recent experience includes being a Crisis Intervention Worker for the Native Women's Centre. This brought daily learnings of indigenous lands, beliefs, ways of living and practices. I have carried with me these teachings I also gained leadership experience serving on the Sexual Assault Centre of Hamilton and Area's management committee, The Children's International Learning Centre Board of Directors, and the Hamilton Community Legal Clinic's board of directors as well.

Back then, I was driven by the desire to advocate for the voices of myself and my fellow students to improve the quality of our education. I realized that if I wanted to see change, I needed to use my voice to advocate for the voice of students.

It's for this reason that I am to be writing this letter to express my interest for the Wards 1 & 2 Trustee Vacancy at the HWDSB. I have grown up in Hamilton for my entire life and attended schools in the HWDSB from junior kindergarten all the way until grade 12. I want to ensure that the voices of marginalized communities are heard and I hope that I have the opportunity to advocate for them again at the board table.

Please accept this submission as my letter of interest and my request in consideration for the position of Trustee of Wards 1 & 2 for the Hamilton Wentworth District School Board.

I am a French-Canadian, Métis single mother of two girls, one in university and one in her first (grade 9) year in the Glendale High School Fine Arts programme. I am a graduate of Brescia College at the University of Western Ontario (1983) earning a Bachelor of Arts in Sociology and of Fanshawe College (1984) earning a Legal Office Administration Certificate. I am one of the early ones to attend college after graduating from university and was a litigation law clerk for approximately 17 years, working for prominent trial counsel in Barrie, Hamilton and Burlington. Since 2001, I have been employed with the Ministry of the Attorney General and the Cities of Burlington and Brampton. For the past 18 years, I have worked as the Bilingual Court and Customer Representative for the City of Brampton. I work primarily as a courtroom clerk/monitor at the Ontario Court of Justice, Provincial Offences Court where I have the opportunity to interact with a spectrum of people with varying socio-economic backgrounds, ethnicities and cultures. That is what I do.

Who I am is a hard working individual who also does her best to support the community where I live. I have been a member of Classic Blend Ladies Barbershop Chorus since 2005 and perform throughout the Greater Hamilton Area. I particularly enjoy performing for the elderly in nursing homes and retirement residences. From 2011 to 2018, I was a member of the Board of Directors for the chorus and held the position of Chair of Fundraising. In 2014/2015, I was a member of the Conseil scolaire de district catholique Centre-Sud, comité des parents on behalf of the Mère Theresa family of schools in Hamilton. In February 2017, The Honourable Chad Collins MP, then a city counsellor, asked me to join the East Hamilton Food Centre Group to assist, plan, and execute the opening and operations of a volunteer based, community driven food bank to service those in need in east Hamilton. I was elected to the Executive Committee in late 2017 was appointed as Vice Chair in 2018. The food bank opened its doors to the public in early 2019. Since then, with the assistance of our service partner Mission Services of Hamilton, we continued to serve the community, with a break in services due to COVID-19 for approximately one year. Mission Services of Hamilton has recently assumed the day-to-day operations of the project on a fulltime basis. The

Executive Committee became redundant and was officially disbanded at the end of 2021.

My late father, Jean Felix Desmarais was a trustee with the HWDSB for many years. I am fully aware of the magnitude and scope of work expected from its board members. While I do not live in Wards 1 or 2 at present, I did grow up downtown in Ward 2. I have lived in the east end of the city for more than 35 years and remain a very proud Hamiltonian. I believe that elementary and secondary education provides the foundation to formal learning, the basis by which our children will launch into their adult lives. Whether a graduate continues on to attend university or college or go straight to securing employment, they should have learned the fundamentals that will carry them into adulthood. The children who do not make it through to high school graduation are a concern for the community at large. It is at school that we might learn what is holding the child back from achieving success. It is necessary to be 'in tune' to our children so that we can provide the support they need to ensure their personal success. With over 100 public schools within the governance of the Board and approximately 50,000 students in those schools, there is a significant amount of work required to ensure that each child receives a superior education experience in the time they are with us.

I have reviewed the qualification criteria of a School Board trustee as set out in the <u>Education Act</u> and I believe that I meet those qualifications. It would be my honour to serve the community at large by becoming, albeit on an interim basis, a trustee for the HWDSB. I declare, in accordance to the requirements of the posting, that I will not stand for election in the Fall 2022 election. I will abide by and do my best to meet all the expectations of the Board and be available to the community as their trustee.

I write to ask for your consideration to fill the Ward 1/2 Trustee vacancy on the current Board.

I have a consistent and extensive track record in the not-for-profit sector in leadership positions. I have the knowledge and ability to execute strong governance in many different settings, including as chair of one board with a budget of over \$13 million. As can be seen on my C.V., which I ask you to find attached, I have enthusiastically and actively participated in my community by working on issues that matter for many years.

My two children are HWDSB students, the elder in high school and the younger in middle school. Their journeys have provided me with a broad view of the challenges which face Ward 1/2.

As a member of the Board of Directors of the Hamilton Foundation for Student Success, and as chair for the past two years, I have developed a deeper understanding of the inequities in publicly-funded education. This is not a challenge unique to Hamilton. However, given systemic inequities such as those seen in the ground-breaking Code Red, Hamilton is a particularly stark case study of the effects of income disparity, race, and gender, amongst other factors upon school success.

I am strongly committed to the furtherance of principles of equity, diversity and inclusion, and if I am selected to fill this vacancy, it is my hope and expectation that this commitment will serve as my lighthouse, and a lens through which I will continually assess my own performance.

I am not a member of a historically disadvantaged group. That said, I have spent the last decade developing a profound understanding of the effects of mental health disability upon one's work. This is an issue of fundamental importance for me. I strongly believe that schools, like other workplaces and systems, must not only respond to outcomes and effects, but must also recognize causes, and translate recognition to policy.

I wish to offer myself for service. I do not seek the position for any other purpose, nor will I run in any capacity on October 24, 2022. I believe my knowledge of the HWDSB, Wards 1 and 2, and my extensive and oft-demonstrated commitment to serve my community through leadership uniquely situates me to fill this vacancy as seamlessly and steadily as possible.

Thank you for the opportunity to address you in writing, and I hope to be granted the opportunity to do so verbally as well.

Thank you all for the opportunity to apply for the vacant position of Wards 1 & 2 Trustee.

As a former Ward 3 Trustee from 2014-2018, many of my constituents attended schools within the Wards 1 & 2 boundary whether it was for elementary, secondary, specialized student services, or for french immersion programming.

With one of my schools also falling within the West Hamilton City Pupil Accommodation Review, I had the opportunity to get to know many Wards 1 & 2 schools through this process which would later include discussions around the community hub plan at SJAM, as well as introducing french immersion programming at Bennetto and any post PAR processes related to this move.

Other issues I was involved with included hydro upgrades adjacent to Dr. Davey, the debate about parents on the playground following the abduction at Earl Kitchener, to the issues with principal funding at Glenwood school which was one of the first facilities I toured as a new Trustee advocating for special needs programs and services.

Through these experiences, my step-daughter attended Earl Kitchener, and as a former Ward 1 resident, I have made many connections and am very familiar with the area. I have also lived in the lower city most of my adult life, and Hamilton as a whole for all but five years.

As a Trustee, I sat on many committees during my four years in this position including FNMI, SAL, and the IEC (Indigenous Education Circle) for which I still remain as a community member today.

Post elected life, I have had a lot of time to grow my learning and have read many books that discuss BIPOC and Jewish histories and experiences over the past few years so although I have never had formal EDI training, my committee work and

continued personal development mean I am very familiar with the challenges our families struggle with every day. Phone calls, coffee chats, and one-on-one encounters in the community through my volunteer work, having run two campaigns for office both municipally and federally, and my four years of elected service have also helped open my mind to the gaps that exist across all equity seeking groups across all of our systems.

I imagine it is very likely that most if not all board and committee meetings will be remote for the remainder of this board which has also been the case for my current employment since the pandemic began. I am proficient with technology so that coupled with my previous board experience makes this transition back into this role a fairly smooth one. I have followed the issues closely these past few years; you can take the person out of the role but not the role out of the person.

With three children still active within HWDSB, as a hockey and baseball coach to many HWDSB kids, I care deeply about the outcomes of the children of Hamilton and especially about their mental and physical wellness through lockdowns and disconnections from their peers and the activities they are passionate about.

Aside from my previous board experience, I am employed by Cogeco Connexion and work in Ward 4 in Hamilton. I have been with Cogeco for nearly 24 years now and as part of my role as Fibre Network Administrator, I work with various internal departments and external partners as part of my position of overseeing the Ontario intercity fibre network. I also serve as a point of contact for these partners and support them in their requests to understand and access the information I am the steward of so working with people on a day-to-day basis is already part of my everyday life.

As a former Trustee, I realize the extra pressures put on those that take on this critical role within our community outside of their full-time employment and family responsibilities.
