RE: 2024-2025 Draft School Year Calendars

Action X Monitoring

Recommended Action:

That the Draft 2024-2025 School Year Calendars be approved for public consultation.

Rationale/Benefits:

The 2024-2025 School Year Calendars (Elementary and Secondary) have been prepared in consultation with the School Year Calendar Advisory Committee and endorsed by Executive Council.

The calendars comply with Ontario Regulation 304, School Year Calendars and Professional Activity Days. As of the date of this report, the Ministry of Education has not released detailed guidance regarding the requirements of Professional Activity Days for 2024-2025. When the HWDSB receives this information, it will be incorporated into the report that brings the School Year Calendar back for final ratification before submission to the Ministry.

Public consultation will be undertaken from December 20, 2023, to January 17, 2024, to receive community feedback regarding the draft calendars.

Background:

Ontario Regulation 304, <u>School Year Calendar, Professional Activity Days</u> sets the requirements for preparation and submission of school year calendars to the Ministry of Education. This includes a minimum of 194 school days between September 1 and June 30. For the 2024-2025 calendar, all required days can occur after Labour Day (Monday, September 2).

Regulation 304 establishes holidays for the school year that include a Winter Holiday Break (December 23, 2024, to January 3, 2025) and the March Break (March 10th, 2025, to March 14th, 2025.). However, to accommodate local needs, school boards may request a modified school year calendar that is organized differently from the criteria outlined in Regulation 304. This year, the draft calendars for the 2024-25 school year do not propose a modification from the Ministry's suggested calendar.

Development of the Draft 2024-2025 School Year Calendars has been undertaken in consultation with the School Year Calendar Advisory Committee which consists of members representing: Elementary and Secondary Principals

(HWPC); Elementary and Secondary Teachers (HWETL, OSSTF, HWOTL); Parents (HW Council of Home & School Associations; HWDSB PIC); Educational Assistants and Child and Youth Care Practitioners (COPE), Early Childhood Educators (HWDECEL), ESL Instructors, Professional Student Services (PSSP) and School Office Assistants (OCTU).

The School Year Calendar Advisory Committee reviewed and provided feedback on the draft elementary and secondary calendars. The committee will meet again in January to review the results of the public consultation process and provide further input. The consultation process will also include discussions with the coterminous board to align PA days wherever possible to reduce transportation costs and disruption.

Professional Activity Days

The Ministry of Education requires school boards to arrange up to seven Professional Activity (PA) days in the school year. The HWDSB is awaiting Ministry guidance on requirements related to the content of PA Days. The specific topics of PA Days will be brought forward in the report seeking final ratification before submission to the Ministry. In our current planning, the PA Day scheduled for Friday, November 22, 2024, in the Elementary draft calendar will be for family, caregiver, and guardian interviews.

Public Consultation & Next Steps

The Draft 2024-25 School Year Calendars will be posted on the HWDSB website from (December 20^{th,} 2023, to January 17^{th,} 2024) for public feedback. The consultation will utilize the Engage platform and an online survey. The results of the consultation will be analysed by HWDSB Research & Analytics Department and provided for review by the Executive Council, the School Year Calendar Advisory Committee, and the Board of Trustees prior to the final ratification of the calendars for submission to the Ministry of Education by March 1st, 2024. The Ministry of Education provides final approval of the school year calendars.

<u>Update on Motion - School Year Calendar (2025-2026), Days of Observances, and Religious Accommodations</u>

On September 18th, 2023, the Board of Trustees passed a motion asking for consultation to occur in regard to the school year calendar, days of observances, and religious accommodations. The consultation regarding these topics will occur throughout the 2023-2024 school year and will inform decisions related to the 2025-2026 school year calendar. The process for this consultation will follow the information provided in the staff reported presented on September 19th, 2023.

RE: Transportation Consortium Update

Background

On an annual basis, the Hamilton-Wentworth Student Transportation Services (HWSTS) reports to the Hamilton-Wentworth District School Board (HWDSB) and Hamilton-Wentworth Catholic District School Board (HWCDSB) on the efforts, undertakings, and results of school year start up and highlights from the prior school year.

Highlights from 2022-23

Route and Vehicle Information – School Bus Operators

HWSTS secured school bus transportation for HWDSB and HWCDSB for an 8-year term starting September 1, 2021 and ending August 31, 2029. The contract contains a possibility of two 1-year extensions. During the 2022-23 school year, the following bus operators supported a combined 472 school bus routes:

- Attridge Transportation Inc. 161 routes
- 2. First Student ULC 160 routes
- 3. Sharp Bus Lines Ltd. 151 routes

In the 2022-23 school year, the 472 routes are supported by the vehicles outlined below:

- 283 full sized buses
- 113 minibuses
- 70 minibuses (adapted)
- 4 mini vans

Route and Vehicle Information – Taxi Operators

Taxis provide differentiated, stable, and reliable transportation to students. HWSTS secured taxi transportation for the HWDSB and HWCDSB for a 3-year term starting September 1, 2022 and ending June 30, 2025. The contract has the option of two 1-year extensions. HWSTS has contracted with both Hamilton Cab and Blue Line Cab.

Routing Configuration

HWSTS employs a multi-tiered bus route system designed to enhance safety and operational efficiency through the following guiding principles:

- Adherence to the HWDSB's transportation policy
- Service multiple schools in close proximity
- Optimize resources by combining runs from different schools onto shared routes.
- Cost effective deployment of resources to minimize the number of vehicles on the road and required drivers
- Minimize overall drive time

September 2023 Start Up

HWSTS continues to tackle the persistent challenges arising from a shortage of drivers, a trend that has persisted for several years.

- As of the end of November 2023, HWSTS is reporting a total of 6 open routes.
- In November 2022, at the same time of the year, we had 28 open routes.

Figure 2, depicted below, illustrates a modest rise in the overall volume of calls. A noteworthy observation is that more than half of the calls were effectively addressed by the answering service.

Incident Reporting

The current established protocol for reporting inappropriate behaviors involves the driver completing a handwritten Incident Report form. Subsequently, the Principal investigates the reported behaviour(s) and communicates the outcome of the investigation to the bus operator and HWSTS. To streamline this process and enhance efficiency, HWSTS is actively working towards transitioning from traditional carbon-copy forms to an online reporting system. This advancement will enable HWSTS to track student behavior on buses.

2022-2023 School Year Safety Initiatives

Annually, HWSTS engages in various educational initiatives, including first rider education, on-site/virtual bus safety training, and the distribution of kindergarten identification tags. Figure 5 illustrates the participation in these programs over the past 5 years.

Bus Driver Professional Development Session

HWSTS organized a bus driver appreciation event in the spring of 2023, a tradition that had been temporarily set aside following the pandemic. This initiative was designed to acknowledge and celebrate the essential contributions of bus drivers. HWSTS is committed to recognizing the dedicated efforts of bus drivers.

Initiatives

In the 2023-24 school year, HWSTS will uphold its commitment to supporting member Boards. The team will prioritize initiatives to meet changing service needs, incorporating GPS technology. HWSTS is currently piloting GPS applications, beginning with First Student's Firstview, which includes a District View dashboard for Consortia monitoring and a Parent View App for families to receive delay notifications.
